4 ENROLLED, An Act,

5 Relating to Perry County; proposing an amendment to
6 the Constitution of Alabama of 1901, to authorize the
7 Legislature to fix, regulate, and alter the fees, commissions,
8 allowances, and salaries, including the method and basis of
9 compensation, to be charged or received by the sheriff of the
10 county.

11 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

12 Section 1. The following amendment to the
13 Constitution of Alabama of 1901, is proposed and shall become
14 valid as a part of the Constitution when all requirements of
15 this act are fulfilled:

16 PROPOSED AMENDMENT

17 The Legislature, from time to time, by general or
18 local laws applicable to or operative in Perry County, may
19 fix, regulate, and alter the fees, commissions, allowances,
20 and salaries, including the method and basis of compensation,
21 to be charged or received by the sheriff of the county; and
22 may place the sheriff on a salary and provide for the fees,
23 commissions, allowances, and percentages collectible by the
24 sheriff, to be paid into the county treasury.

1 Section 2. An election upon the proposed amendment
2 shall be held in accordance with Amendment 555 to the
3 Constitution of Alabama of 1901, now appearing as Section
4 284.01 of the Official ReCompilation of the Constitution of
5 Alabama of 1901, as amended, and the election laws of this
6 state.

7 Section 3. The appropriate election official shall
8 assign a ballot number for the proposed constitutional
9 amendment on the election ballot and shall set forth the
10 following description of the substance or subject matter of
11 the proposed constitutional amendment:

12 "Relating to Perry County; proposing an amendment to
13 the Constitution of Alabama of 1901, to authorize the
14 Legislature to fix, regulate, and alter the fees, commissions,
15 allowances, and salaries, including the method and basis of
16 compensation, to be charged or received by the sheriff of the
17 county.

18 "Proposed by Act _____."

19 This description shall be followed by the following
20 language:
