BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

Section 1. Section 11-43-50 of the Code of Alabama 1975, is amended to read as follows:

"\$11-43-50.

"(a) There shall be at least two regular meetings of the council in each month, except that in towns, as defined in section 11-40-6, there shall be at least one regular meeting of the council in each month; but provided, however, the council of any town may, by ordinance, mandate at least two regular meetings of the council in each month, and the presiding officer shall call special meetings whenever in his or her opinion the public interest may require it and whenever two aldermen council members or the mayor request him the presiding officer in writing to call such a meeting. Upon the failure or refusal of the presiding officer to call such a meeting when requested, the two aldermen council members or the mayor making the request shall have the right to call such the meeting.

"(b) A council member may notify the presiding officer in writing when the member will be unable to attend a council meeting. If the presiding officer receives sufficient written notice to indicate that a quorum will not be present at a meeting, the presiding officer may cancel the meeting and give notice that the meeting is canceled. If a meeting
