4 ENROLLED, An Act,

5 Relating to Jackson County; to propose an amendment
6 to the Constitution of Alabama of 1901, to repeal Amendment
7 No. 846 of the Constitution of Alabama of 1901, now appearing
8 as Section 1.50, Jackson County, Local Constitutional
9 Amendments of the Official Recompilation of the Constitution
10 of Alabama of 1901, as amended, which requires the county
11 commission to call a special election for any vacancy
12 occurring in a county office in the county when 12 months or
13 more remain in the term.

14 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

15 Section 1. The following amendment to the
16 Constitution of Alabama of 1901, is proposed and shall become
17 valid as a part of the Constitution when all requirements of
18 this act are fulfilled:

19 PROPOSED AMENDMENT

20 Amendment No. 846 of the Constitution of Alabama of
21 1901, now appearing as Section 1.50, Jackson County, Local
22 Constitutional Amendments of the Official Recompilation of
23 the Constitution of Alabama of 1901, relating to special
24 elections to fill vacancies in county offices, is repealed.

1 Section 2. An election upon the proposed amendment
2 shall be held in accordance with Amendment 555 to the
3 Constitution of Alabama of 1901, now appearing as Section
4 284.01 of the Official Recompilation of the Constitution of
5 Alabama of 1901, as amended, and the election laws of this
6 state.

7 Section 3. The appropriate election official shall
8 assign a ballot number for the proposed constitutional
9 amendment on the election ballot and shall set forth the
10 following description of the substance or subject matter of
11 the proposed constitutional amendment:

12 "Proposing a local constitutional amendment relating
13 to Jackson County, to repeal Amendment No. 846 of the
14 Constitution of Alabama of 1901, now appearing as Section
15 1.50, Jackson County, Local Constitutional Amendments of the
16 Official Recompilation of the Constitution of Alabama of 1901,
17 as amended, relating to special elections to fill vacancies
18 occurring in county offices.

19 "Proposed by Act _____."

21 language:
