6 ENROLLED, An Act,

7 Relating to Barbour County, and particularly the
8 Barbour County Board of Education School Tax District No. 1 in
9 the county; providing for an increase of the district ad
10 valorem school tax by four mills, all in accordance with
11 Amendment No. 373 to the Alabama Constitution; the increased
12 tax to be levied and collected in the School Tax District No.
13 1 for each year beginning with the levy for the tax year
14 October 1, 2012 to September 30, 2013 (the tax for which year
15 will be due and payable October 1, 2013) and ending with the
16 levy for the tax year October 1, 2042 to September 30, 2043
17 (the tax for which year will be due and payable October 1,
18 2043) for public school purposes in the School Tax District
19 No. 1; provided that the increased rate of the tax, the time
20 it is to continue, and the purpose thereof shall have been
21 first submitted to the vote of the qualified electors of
22 School Tax District No. 1 in Barbour County at an election
23 called and held in accordance with the applicable laws
24 governing elections.

25 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

1 Section 1. In addition to any taxes now authorized
2 or that may hereafter be authorized by the Constitution and
3 laws of the State of Alabama, there is hereby approved an
4 additional special district ad valorem tax to be levied and
5 collected annually in the Barbour County Board of Education
6 School Tax District No. 1 (as hereinafter described) in
7 Barbour County for public school purposes in the district at
8 the uniform rate of forty cents on each one hundred dollars
9 worth of taxable property in the district pursuant to the
10 provisions of Amendment No. 373 to the Constitution of Alabama
11 of 1901 for a period of 30 years beginning with the levy for
12 the tax year October 1, 2012 to September 30, 2013 (the tax
13 for which year to be due and payable October 1, 2013) and
14 ending with the levy for the tax year October 1, 2042 to
15 September 30, 2043 (the tax for which year to be due and
16 payable October 1, 2043), the levy and collection, if
17 authorized, to operate to increase the district school tax
18 authorized to be levied and collected pursuant to law in
19 School Tax District No. 1, which constitutes and includes, for
20 purposes of the levy and collection of the additional four
21 mill tax, all of Barbour County outside the corporate limits
22 of the City of Eufaula, and outside of Eufaula City Board of
23 Education School Tax District No. 55 in Barbour County, for
24 the proposed collection of the additional tax on October 1,
25 2013, and for the proposed collection of such additional tax

1 on October 1 in each of the years 2014 through 2043,
2 inclusive; provided, that the increased rate of tax, the time
3 it is to continue, and the purpose thereof shall have been
4 first submitted to the vote of the qualified electors of
5 Barbour County Board of Education School Tax District No. 1,
6 which includes the qualified electors of Barbour County
7 outside the corporate limits of the City of Eufaula, and
8 approved by a majority of those voting at an election called
9 and held in accordance with applicable law governing
10 elections.

11 Section 2. This act shall become effective
12 immediately following its passage and approval by the
13 Governor, or its otherwise becoming law.
