On the effective date of this act, any 12 13 unexpended funds from line-item appropriations under the 14 Department of Agriculture and Industries for the following 15 shall be reverted to the Administrative Services Program of 16 the Department of Agriculture and Industries: Farm and Ranch 17 Lands Protection Program; expenses and awarding of prizes for fairs as provided in Section 2-7-21, Code of Alabama 1975, and 18 other livestock shows exhibits and the Livestock Coliseum and 19 other activities as deemed necessary by the Agricultural 20 21 Center Board; Treasure Forest Program; Center for Alternative 22 Fuels; rabbit production and promotion; and the North Alabama 23 Agriplex.

24 Section 18. In addition to all other appropriations 25 heretofore or hereafter made, there is hereby appropriated

\$120,000 from the Archives Services Fund to the Department of
 Archives and History for the fiscal year ending September 30,
 2011.

Section 19. This act shall become effective
immediately upon its passage and approval by the Governor, or
upon its otherwise becoming law.
