5 To amend Act 2010-553 in order to reduce the
6 absolute appropriation from the State General Fund to the
7 Alabama Department of Corrections in the amount of \$6,331,271
8 for the fiscal year ending September 30, 2011; to make a
9 supplemental appropriation from the DOC Miscellaneous and
10 Federal Funds (Bonus), Estimated to the Alabama Department of
11 Corrections in the amount of \$54,965,407 for the fiscal year
12 ending September 30, 2011; to make a supplemental
13 appropriation from the State General Fund to the Alabama
14 Medicaid Agency in the amount of \$125,615,631 for the fiscal
15 year ending September 30, 2011; to make a supplemental
16 appropriation from the State General Fund to the Alabama
17 Department of Senior Services in the amount of \$527,348 for
18 the fiscal year ending September 30, 2011; to make a
19 supplemental appropriation from the State General Fund to the
20 Alabama Department of Human Resources in the amount of
21 \$1,423,711 for the fiscal year ending September 30, 2011; to
22 make a supplemental appropriation from the State General Fund
23 to the Department of Mental Health in the amount of \$6,620,000
24 for the fiscal year ending September 30, 2011; to make a
25 supplemental appropriation from the State General Fund to the

1 Alabama Department of Public Health in the amount of
2 \$12,798,452 for the fiscal year ending September 30, 2011; to
3 make a supplemental appropriation from the State General Fund
4 to the Alabama Department of Rehabilitation Services in the
5 amount of \$392,402 for the fiscal year ending September 30,
6 2011; to make a supplemental appropriation from the State
7 General Fund to the Alabama Department of Youth Services in
8 the amount of \$219,304 for the fiscal year ending September
9 30, 2011; to make a supplemental appropriation from the State
10 General Fund to the Alabama Board of Pardons and Paroles in
11 the amount of \$7,844,462 for the fiscal year ending September
12 30, 2011; to make a supplemental appropriation from the State
13 General Fund to the Alabama Ethics Commission in the amount of
14 \$617,537 for the fiscal year ending September 30, 2011; to
15 make a supplemental appropriation from the State General Fund
16 to the Office of the State Auditor in the amount of \$159,002
17 for the fiscal year ending September 30, 2011; to make a
18 supplemental appropriation from the State General Fund to the
19 State Military Department in the amount of \$993,000 for the
20 fiscal year ending September 30, 2011; to make a supplemental
21 appropriation from the State General Fund to the Departmental
22 Emergency Fund in the amount of \$4,280,000 for the fiscal year
23 ending September 30, 2011; and to make a supplemental
24 appropriation from the Archives Services Fund to the
25 Department of Archives and History in the amount of \$120,000

1 for the fiscal year ending September 30, 2011; and to delete
2 certain unexpended line-item appropriations in the Department
3 of Agriculture and Industries; and to make a supplemental
4 appropriation from the State General Fund to the Alabama
5 District Attorneys in the amount of \$750,000 for the fiscal
6 year ending September 30, 2011; and to make a supplemental
7 appropriation from the State General Fund in the amount of
8 \$350,000 to the Department of Forensic Sciences for the fiscal
9 year ending September 30, 2011.

10 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

11 Section 1. Amend Act 2010-553, Section 2C, at the
12 end of Subsection 35 entitled "Corrections, Department of:" by
13 adding the following language: "The above appropriation to the
14 Alabama Department of Corrections from the State General Fund
15 shall be reduced by \$6,331,271."

16 Section 2. In addition to all other appropriations
17 heretofore or hereafter made, there is hereby appropriated
18 \$54,965,407 from the DOC Miscellaneous and Federal Funds
19 (Bonus), Estimated to the Alabama Department of Corrections
20 for the fiscal year ending September 30, 2011.

21 Section 3. In addition to all other appropriations
22 heretofore or hereafter made, there is hereby appropriated
23 \$125,615,631 from the State General Fund to the Alabama
24 Medicaid Agency for the fiscal year ending September 30, 2011.

1 Section 4. In addition to all other appropriations
2 heretofore or hereafter made, there is hereby appropriated
3 \$527,348 from the State General Fund to the Alabama Department
4 of Senior Services for the fiscal year ending September 30,
5 2011.

6 Section 5. In addition to all other appropriations
7 heretofore or hereafter made, there is hereby appropriated
8 \$1,423,711 from the State General Fund to the Alabama
9 Department of Human Resources for the fiscal year ending
10 September 30, 2011.

11 Section 6. In addition to all other appropriations
12 heretofore or hereafter made, there is hereby appropriated
13 \$6,620,000 from the State General Fund to the Alabama
14 Department of Mental Health for the fiscal year ending
15 September 30, 2011.

16 Section 7. In addition to all other appropriations
17 heretofore or hereafter made, there is hereby appropriated
18 \$12,798,452 from the State General Fund to the Alabama
19 Department of Public Health for the fiscal year ending
20 September 30, 2011.

21 Section 8. In addition to all other appropriations
22 heretofore or hereafter made, there is hereby appropriated
23 \$392,402 from the State General Fund to the Alabama Department
24 of Rehabilitation Services for the fiscal year ending
25 September 30, 2011.

1 Section 9. In addition to all other appropriations
2 heretofore or hereafter made, there is hereby appropriated
3 \$219,304 from the State General Fund to the Alabama Department
4 of Youth Services for the fiscal year ending September 30,
5 2011.

6 Section 10. In addition to all other appropriations
7 heretofore or hereafter made, there is hereby appropriated
8 \$7,844,462 from the State General Fund to the Alabama Board of
9 Pardons and Paroles for the fiscal year ending September 30,
10 2011.

11 Section 11. In addition to all other appropriations
12 heretofore or hereafter made, there is hereby appropriated
13 \$617,537 from the State General Fund to the Alabama Ethics
14 Commission for the fiscal year ending September 30, 2011.

15 Section 12. In addition to all other appropriations
16 heretofore or hereafter made, there is hereby appropriated
17 \$159,002 from the State General Fund to the Office of the
18 State Auditor for the fiscal year ending September 30, 2011.

19 Section 13. In addition to all other appropriations
20 heretofore or hereafter made, there is hereby appropriated
21 \$993,000 from the State General Fund to the State Military
22 Department for the fiscal year ending September 30, 2011.

23 Section 14. In addition to all other appropriations
24 heretofore or hereafter made, there is hereby appropriated

1 \$4,280,000 from the State General Fund to the Departmental
2 Emergency Fund for the fiscal year ending September 30, 2011.

3 Section 15. In addition to all other appropriations
4 heretofore or hereafter made, there is hereby appropriated
5 \$750,000 from the State General Fund to the Alabama District
6 Attorneys for the fiscal year ending September 30, 2011.

7 Section 16. In addition to all other appropriations
8 heretofore or hereafter made, there is hereby appropriated
9 \$350,000 from the State General Fund to the Department of
10 Forensic Sciences for the fiscal year ending September 30,
11 2011.

12 Section 17. On the effective date of this act, any
13 unexpended funds from line-item appropriations under the
14 Department of Agriculture and Industries for the following
15 shall be reverted to the Administrative Services Program of
16 the Department of Agriculture and Industries: Farm and Ranch
17 Lands Protection Program; expenses and awarding of prizes for
18 fairs as provided in Section 2-7-21, Code of Alabama 1975, and
19 other livestock shows exhibits and the Livestock Coliseum and
20 other activities as deemed necessary by the Agricultural
21 Center Board; Treasure Forest Program; Center for Alternative
22 Fuels; rabbit production and promotion; and the North Alabama
23 Agriplex.

24 Section 18. In addition to all other appropriations
25 heretofore or hereafter made, there is hereby appropriated

1 \$120,000 from the Archives Services Fund to the Department of
2 Archives and History for the fiscal year ending September 30,
3 2011.

4 Section 19. This act shall become effective
5 immediately upon its passage and approval by the Governor, or
6 upon its otherwise becoming law.
