To propose an amendment to the Constitution of Alabama of 1901, relating to Madison County, to authorize the Madison County Commission, by resolution, to establish a procedure by which a dog can be declared dangerous, to impose civil penalties on the owner of a dog that inflicts severe personal harm on another person, and to require that a dangerous dog be kept in a fenced enclosure.

BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

Section 1. The following amendment to the Constitution of Alabama of 1901, is proposed and shall become valid as a part of the Constitution when all requirements of this act are fulfilled:

PROPOSED AMENDMENT

The Madison County Commission, by resolution applicable to those areas of Madison County outside the corporate limits of any municipality, may establish a procedure by which a dog can be declared dangerous, may impose civil penalties on the owner of a dog that inflicts severe personal harm on another person, and may require that dangerous dogs, as defined by the commission, be kept in a fenced enclosure, as defined by the commission, with input from the local humane society.

1	Section 2. An election upon the proposed amendment
2	shall be held in accordance with Amendment 555 to the

4	284.01 of the Official Recompilation of the Constitution of
