2.6	BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

Section 1. There is created an additional district judgeship for the Eighteenth Judicial Circuit which shall be designated judgeship number 3. This judgeship shall be filled at the next general election following its preclearance under Section 5 of the Voting Rights Act of 1965, 42 U.S.C. § 1973c and release of the conditional appropriation made by Section 4 of this act. The first judge elected pursuant to this section shall serve for a six-year term, holding office from the first Monday following the second Tuesday in January after the general election at which that judge is elected.

Section 2. The judge provided in Section 1 shall have and shall exercise all the jurisdiction, power, rights, and authority and shall possess all of the qualifications, perform all of the duties, and shall be subject to all of the responsibilities and duties of the office to which other district judges are subject.

Section 3. The annual compensation of the district judge provided pursuant to this act shall be in accordance with the provisions of Chapter 10A, Title 12, Code of Alabama 1975, including, but not limited to, the provisions that no district judge first elected or appointed to office after October 1, 2001, shall be provided a salary supplement or expense allowance.

Section 4. There is hereby conditionally appropriated form the State General Fund such additional funds as may be required, as determined by the Director of Finance, to fully fund the additional judgeship provided for by this

act for each fiscal year a judgeship is filled pursuant to 1 2 this act and for the following fiscal year if funding for the following fiscal year is not provided for in the general 3 appropriations act or other appropriation act. These appropriations are conditioned upon the availability of funds 5 in the State General Fund, the recommendation of the Director 6 7 of Finance, and the approval of the Governor. Initial filling of this judgeship is contingent upon release of the applicable 8 conditional appropriations made by this bill. 9 10 Section 5. This act shall become effective 11 immediately following its passage and approval by the

Governor, or its otherwise becoming law.
