2 <u>ENROLLED</u>, An Act,

Relating to Shelby County; to further amend Section 7 of Act 248, of the 1975 Regular Session (Acts 1975, p. 778), as last amended by Act 93-496, 1993 Regular Session (Acts 1993, p. 835), relating to the installation and maintenance of an improved system of recording title to property and other documents recorded in the office of the judge of probate and the collection and disposition of a special index fee therefor, so as to further provide for the index fee and distribution of the additional fee.

BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

Section 1. Section 7 of Act 248 of the 1975 Regular Session (Acts 1975, p. 778), as last amended by Act 93-496, 1993 Regular Session (Acts 1993, p. 835), is further amended to read as follows:

"Section 7. Special Recording Fees. A special index fee of six dollars (\$6) shall be paid to the county, and collected by the judge of probate with respect to each real property instrument and each personal property instrument filed for record in the office of the judge of probate and for the recording of other instruments and documents in the probate office in the discretion of the governing body of the county. After the effective date, no instrument shall be recorded in the office of the judge of probate unless the

1	special index fee of six dollars (\$6) is paid. The special
2	index fee shall be in addition to all other fees, taxes, and
3	other charges required by law for recording any real property
4	instrument or personal property instrument, and for the
5	recording of other instruments and documents in the office of
6	the judge of probate in the discretion of the governing body
7	of the county. All special index fees collected shall be
8	deposited into the county treasury and credited to the account
9	of a special fund to be expended as follows:

- "(1) Of the fee collected, four dollars (\$4) shall be designated for payment of initial installation costs and the cost as needed of additional equipment that may be added to the probate office from time to time.
- "(2) Of the fee collected, two dollars (\$2) shall be designated for the operating expenses of the Shelby County Constituents' Office. The fund shall be managed by the chair of the Shelby County Legislative Delegation Office.

"Any sums deposited or collected in excess those needed to implement this act, in the sole discretion of the judge of probate, may be expended for the operations of the office of the judge of probate."

Section 2. This act shall become effective on the first day of the third month following its passage and approval by the Governor, or its otherwise becoming law.
