25	accordance with Sections 284, 285, and 287 of the Constitution
26	of Alabama of 1901, as amended:
27	PROPOSED AMENDMENT

(a) After January 1, 2010, no county or municipality
may impose a privilege or license tax on the gross receipts of
any natural person derived from the conduct of a vocation,
occupation, calling, or profession within the county or
municipality. This amendment shall not apply to any such
privilege or license tax imposed on the effective date of this
amendment.

8 (b) Nothing in this amendment is intended to repeal 9 or affect the current authority granted by local act or 10 otherwise to impose business licenses or the current authority 11 granted to municipalities to impose municipal business 12 licenses.

Section 2. An election upon the proposed amendment shall be held in accordance with Sections 284 and 285 of the Constitution of Alabama of 1901, now appearing as Sections 284 and 285 of the Official Recompilation of the Constitution of Alabama of 1901, as amended, and the election laws of this state.

19 Section 3. The appropriate election official shall 20 assign a ballot number for the proposed constitutional 21 amendment on the election ballot and shall set forth the 22 following description of the substance or subject matter of 23 the proposed constitutional amendment:
