8 SYNOPSIS: This bill would propose a local
9 constitutional amendment relating to Baldwin County
10 to define the Stockton Landmark District within the
11 county and to prohibit the annexation by local law
12 of any property within the district into any
13 municipality.

16 TO BE ENTITLED

19 To propose an amendment to the Constitution of
20 Alabama of 1901, relating to Baldwin County, to define the
21 Stockton Landmark District within the county and to prohibit
22 the annexation by local law of any property within the
23 district into any municipality.

24 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

25 Section 1. The following amendment to the
26 Constitution of Alabama of 1901, is proposed and shall become

1 valid as a part of the Constitution when all requirements of
2 this act are fulfilled:

3 PROPOSED AMENDMENT

4 (a) For the purposes of this amendment, the
5 "Stockton Landmark District" is defined as follows:

6 Beginning at the point where I-65 intersects the
7 line which divides R2E and R3E; thence, north to Little Halls
8 Creek; thence, follow Little Halls Creek in a westwardly
9 direction to Halls Creek; thence, follow Halls Creek to Tensaw
10 Lake; thence, follow meanders of Tensaw Lake in a southerly
11 direction until it meets the Tensaw River; thence, follow
12 meanders of Tensaw River until it meets I-65; thence, follow
13 I-65 in E/NE direction to point of beginning.

14 (b) No property within the Stockton Landmark
15 District may be annexed into any municipality by local law.

16 Section 2. An election upon the proposed amendment
17 shall be held in accordance with Amendment 555 to the
18 Constitution of Alabama of 1901, now appearing as Section
19 284.01 of the Official Recompilation of the Constitution of
20 Alabama of 1901, as amended, and the election laws of this
21 state.

22 Section 3. The appropriate election official shall
23 assign a ballot number for the proposed constitutional
24 amendment on the election ballot and shall set forth the
25 following description of the substance or subject matter of
26 the proposed constitutional amendment:

1 "Relating to Baldwin County, proposing an amendment
2 to the Constitution of Alabama of 1901, to define the Stockton
3 Landmark District within the county and to prohibit the
4 annexation by local law of any property within the district
5 into any municipality.

6 "Proposed by Act _____."

7 This description shall be followed by the following
8 language:

9 "Yes () No ()."
