Amendment 621 of the Constitution of Alabama 14 15 of 1901, now appearing as Section 111.05 of the 16 Official Recompilation of the Constitution of 17 Alabama of 1901, as amended, prohibits a general 18 law whose purpose or effect would be to require a 19 new or increased expenditure of local funds from 20 becoming effective with regard to a local 21 governmental entity without enactment by a 2/3 vote 22 unless: it comes within one of a number of 23 specified exceptions; it is approved by the 24 affected entity; or the Legislature appropriates 25 funds, or provides a local source of revenue, to 26 the entity for the purpose.

The purpose or effect of this bill would be 1 2 to require a new or increased expenditure of local funds within the meaning of the amendment. 17	Section 2. Although this bill would have as its
18	purpose or effect the requirement of a new or increased
19	expenditure of local funds, the bill is excluded from further
20	requirements and application under Amendment 621 because the
21	bill defines a new crime or amends the definition of an
22	existing crime.
23	Section 3. This act shall become effective on the
24	first day of the third month following its passage and
25	approval by the Governor, or its otherwise becoming law.
