(a) For the purposes of this amendment, the "Stapleton Landmark District" in Baldwin County is defined as follows:

LESS AND EXCEPT therefrom any portion of the above described property which lies within the Corporate Limits of the City of Loxley, the City of Spanish Fort or the City of Bay Minette, Alabama.

- (b) No property within the Stapleton Landmark

  District may be annexed into any municipality by local law.
- (c) Subsection (b) shall not apply to any municipality incorporated after the ratification of this amendment which includes any part of the Stapleton Landmark District.
- (d) The Stapleton Landmark District shall not be considered a legal entity and shall not have any of the following powers or authority:
  - (1) Standing to sue or be sued.
  - (2) Taxing authority.
  - (3) Zoning authority.
  - (4) Police power and public safety authority.
- (5) Authority to adopt ordinances, rules, or regulations within its boundaries.
- 24 (6) Any other authority or power commonly associated with a legal entity.
- Section 2. An election upon the proposed amendment shall be held at the general election in November 2020 in
