19	To amend Section 17-3-8, Code of Alabama 1975, as
20	last amended by Act 2021-243 of the 2021 Regular Session,
21	relating to meeting days of boards of registrars; to increase
22	the maximum number of working days the Wilcox County Board of
23	Registrars may meet each fiscal year.
24	BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:
25	Section 1. Section 17-3-8, Code of Alabama 1975, as
26	last amended by Act 2021-243 of the 2021 Regular Session, is
27	amended to read as follows:

"§17-3-8.

2 "(a) Each member of the board of registrars in the Counties of Clay, Cleburne, Coosa, Dallas, Escambia, Geneva, 3 Lowndes, Perry, and Sumter, and Wilcox may meet a maximum of 4 5 120 working days each fiscal year; each member of the board of 6 registrars in the Counties of Barbour, Blount, Butler, 7 Fayette, Greene, Marengo, Pickens, Pike, Randolph, and Winston may meet a maximum of 168 working days each fiscal year, 8 9 except in Pike County each board of registrars may meet up to 10 an additional 30 session days each fiscal year, at the discretion of the chair of the county commission, and such 11 12 days shall be paid from the respective county funds; each 13 member of the board of registrars in the Counties of Coffee, 14 Talladega, and Tallapoosa may meet a maximum of 220 working 15 days each fiscal year, except that in Talladega County the board of registrars may meet up to an additional 30 session 16 days each fiscal year, at the discretion of the chair of the 17 18 county commission; each member of the board of registrars in the Counties of Dale, Franklin, Houston, Marion, Marshall, 19 20 Bullock, Macon, and Tuscaloosa may meet a maximum of 216 21 working days each fiscal year; each member of the board of 22 registrars in the Counties of Limestone and, Shelby, and 23 Wilcox may meet a maximum of 167 working days each fiscal 24 year; and each member of the board of registrars in Russell County may meet a maximum of 177 working days each fiscal 25 year. 26

"(b) In the Counties of Choctaw, Colbert, Cullman,
Lauderdale, and Monroe, each member of the board of registrars
may meet a maximum of 199 working days each fiscal year.

"(c) Each member of the Board of Registrars of 4 5 Autauga, Elmore, and Bibb Counties may meet a maximum of 187 6 working days each fiscal year. Each member of the Board of 7 Registrars of Walker County may meet a maximum of 200 days each fiscal year, and each member of the Board of Registrars 8 9 of Lamar, Cherokee, Clarke, Conecuh, Crenshaw, Hale, and 10 Washington Counties may meet a maximum of 140 days each fiscal year. Each member of the board of registrars in the following 11 counties may meet the following maximum number of working days 12 13 each fiscal year: Henry - 140 working days; Covington - 188 working days; DeKalb - 207 working days; Jackson - 207 working 14 15 days; Etowah - 207 working days; Chambers - 180 working days; 16 and Lawrence - 140 working days.

"(d) Each member of the board of registrars in the 17 18 Counties of Baldwin, Calhoun, Chilton, Lee, Madison, Mobile, Montgomery, St. Clair, and Morgan are authorized to meet not 19 20 more than five days each week for the purpose of carrying out 21 their official duties. Jefferson County, which is now 22 operating under the provisions of local laws, shall be exempted from this section. Provided, however, that where the 23 24 term each year is used in the local laws the term means each 25 fiscal year.

"(e) The actual number of working days to be used as session days shall be determined by a quorum of the board of registrars according to the needs of the county.

"(f) As many as 25 of the allotted working days may 4 5 be used for special registration sessions (i.e., those sessions held away from the courthouse in the several 6 7 precincts of the county or sessions held on Saturday or between the hours of 5:00 p.m. and 9:00 p.m.). Notice of any 8 special session scheduled by the board shall be given at least 9 10 10 days prior to the special session by: (1) Bills posted at three or more public places in each election precinct 11 affected, if the session involves precinct visits; and (2) 12 13 advertisement once a week for two successive weeks in a 14 newspaper published in the county or by radio or television 15 announcements on a local station, or both by newspaper or 16 announcement."

17 Section 2. This act shall become effective on the 18 first day of the third month following its passage and 19 approval by the Governor, or its otherwise becoming law.
