21	BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:
22	Section 1. For the purposes of this act, the
23	following words have the following meanings:
24	(1) ADVANCED DIAGNOSTIC IMAGING (ADI). The use of
25	equipment for any of the following procedures:
26	a. Computed Tomography (CT).
27	b. Fluoroscopy.

- 1 c. Magnetic Resonance Imaging (MRI).
- d. Nuclear Medicine.

- e. Positron Emission Tomography (PET).
- f. Other advanced imaging procedures as determined by the agency.
 - (2) ADVISORY COMMITTEE. The Radiologic Imaging and Radiation Therapy Advisory Committee.
 - (3) AGENCY. The State Radiation Control Agency.
 - organization or institution that specializes in the certification and registration of radiologic imaging or radiation therapy technical personnel that is accredited by the National Commission for Certifying Agencies, American National Standards Institute, the International Organization for Standardization, or another organization that accredits certification organizations recognized by the agency.
 - (5) IONIZING RADIATION. Gamma rays and Xrays; alpha and beta particles, high-speed electrons, neutrons, protons, and other nuclear particles; but not sound or radio waves or visible, infrared, or ultraviolet light.
 - (6) NONCERTIFIED TECHNICIAN. A person who is employed by a licensed physician, dentist, chiropractor, podiatrist, or his or her private office or clinic, and is registered to perform only radiography procedures not involving the administration or utilization of contrast media or advanced diagnostic imaging, and who is under the

supervision of a licensed physician, dentist, chiropractor, or podiatrist.

- (7) NUCLEAR MEDICINE. The performance of in vivo and in vitro imaging measurements and the use of radioactive substances or advanced diagnostic imaging for therapeutic or research purposes.
 - (8) NUCLEAR MEDICINE TECHNOLOGIST. A person who has completed education and training in the modality of nuclear medicine, is licensed by the agency, and whose scope of practice is limited to performing advanced diagnostic imaging specific to his or her certification.
 - (9) PERSON. An individual natural person only.
- (10) RADIATION THERAPIST. A person who has completed education and training in the modality of radiation therapy, is licensed by the agency, and whose scope of practice is limited to performing advanced diagnostic imaging specific to his or her certification.
- (11) RADIATION THERAPY. The use of ionizing radiation in the treatment of a medical condition.
- (12) RADIOGRAPHER. A person who has completed education and training in the modality of radiography, is licensed by the agency, and whose scope of practice is limited to performing advanced diagnostic imaging or radiography specific to his or her certification.
- (13) RADIOGRAPHY. The process of obtaining an image using external ionizing radiation for diagnostic or therapeutic purposes.

Section 2. (a) Except as otherwise provided in this
act, after January 1, 2023, it shall be unlawful for any
person or business to allow a person to perform radiography,
advanced diagnostic imaging, or radiation therapy, unless the
person is licensed by or registered with the agency in
accordance with this act and the rules adopted pursuant to

this act.

- (b) The agency shall issue licenses to a person who has completed the appropriate education and training requirements and obtained a certification from a certification organization to perform radiography, advanced diagnostic imaging, or radiation therapy.
- (c) Except as provided in Sections 3 and 5, no person, corporation, or facility shall knowingly employ a person who is not licensed by or registered with the agency under this act to perform radiography, advanced diagnostic imaging, or radiation therapy.
- (d) The licensure and registration provisions of this act shall not apply to any of the following:
- (1) A physician licensed to practice in this state who performs radiography, advanced diagnostic imaging, or radiation therapy.
- (2) A podiatrist licensed to practice in this state who performs radiography.
- (3) A chiropractor licensed to practice in this state who performs radiography.

1 (4) A dentist, dental hygienist, or dental assistant 2 licensed in this state who performs radiography.

- (5) A physician in a residency program or a student enrolled in and attending a school or college of medicine or osteopathy in this state who performs radiography, advanced diagnostic imaging, or radiation therapy under the supervision of a licensed physician.
- (6) A dental student enrolled in and attending a dental school in this state who performs radiography under the supervision of a licensed dentist.
- (7) A student enrolled in and attending a radiography, radiation therapy, or nuclear medicine school or program in this state under the supervision of a licensed physician and a radiographer, radiation therapist, or nuclear medicine technologist.
- (8) A person employed by the United States government performing radiography, advanced diagnostic imaging, and radiation therapy when associated with that employment.
- (9) A person performing radiography, advanced diagnostic imaging, and radiation therapy on nonhuman subjects or cadavers.

Section 3. (a) Notwithstanding the provisions of this act, a noncertified technician who performs radiography may continue to do so under the supervision of a licensed physician, dentist, chiropractor, or podiatrist, provided the noncertified technician registers with the agency and meets

the requirements of this section. The agency shall not charge a fee for this registration.

- (b) A noncertified technician who only performs radiography shall register with the agency and is subject to all of the following requirements:
 - (1) The person shall be at least 18 years of age.
 - (2) The person shall complete continuing education in radiologic procedures, techniques, and positioning, and in radiation safety as determined by the agency.
 - (c) A noncertified technician may not be employed to perform radiography as his or her primary duty or responsibility.
 - Section 4. (a) The State Radiation Control Agency shall establish and provide administrative support for a Radiologic Imaging and Radiation Therapy Advisory Committee. The advisory committee shall advise and make recommendations to the agency. The advisory committee shall consist of the following six members:
 - (1) Three persons licensed under this act appointed by the Alabama Society for Radiologic Technologists.
 - (2) Three licensed physicians, consisting of one radiologist and one radiation oncologist appointed by the Alabama Academy of Radiology and one family physician appointed by the Alabama Academy of Family Physicians.
 - (b) The appointing authorities shall coordinate his or her appointments to reflect the racial, gender, and geographic diversity of the state.

- 1 (c) The agency, based on advice and recommendations 2 from the advisory committee, shall do all of the following:
- 3 (1) Adopt rules for the issuance of licenses to
 4 persons performing radiography, advanced diagnostic imaging,
 5 and radiation therapy.

- (2) Set fees and requirements for the issuance of new licenses and renewal of licenses.
- (3) Provide for the acceptance of certification and registration by a certification organization recognized by the board as qualification for licensure.
- (4) Establish requirements for the recognition of licenses issued by other states.
- (5) Provide for the issuance of expedited licenses to retired military personnel and spouses of active duty military personnel.
- (6) Provide for the denial, suspension, revocation, or refusal to renew a license.
- 18 (d) The agency shall establish the scope of practice for all persons licensed under this act based upon nationally 19 2.0 recognized standards of certification organizations. 21 Notwithstanding the foregoing, all persons licensed under this act shall only perform procedures specific to his or her 22 23 certification; shall be prohibited from practicing medicine, 24 osteopathy, or radiology; and shall be prohibited from 25 ordering, interpreting, or rendering preliminary or final diagnostic imaging, studies, or reports. 26

(e) Nothing in this act shall limit or enlarge the scope of practice of any person exempted from licensure under this act.

- (f) The advisory committee shall comply with the Alabama Open Meetings Act in connection with any meeting. Notwithstanding the provisions of that act, the advisory committee may conduct meetings by teleconference or other electronic means.
- (g) All fees payable pursuant to this act shall be collected by the agency and shall be deposited in the State Treasury to the credit of a fund to be known as the Radiologic Imaging and Radiation Therapy Fund. Money in the fund may be expended upon appropriation by the Legislature for the sole purpose of carrying out this act. Any money in the fund at the end of a fiscal year shall be carried over in the fund from year-to-year and shall not revert to the State General Fund at the end of the fiscal year.

Section 5. An assistant to a physician who practices under an active supervisory agreement with a physician under Section 34-24-303, Code of Alabama 1975; a certified registered nurse practitioner or certified nurse midwife who practices under an active collaborative agreement with a physician under Section 34-21-90, Code of Alabama 1975; or a certified registered nurse anesthetist who practices under the direction of a physician pursuant to Section 34-21-81(4)(c), Code of Alabama 1975; who has been engaged in the practice of radiography or advanced diagnostic imaging on or before

December 31, 2022, and who does not hold a current

certification by a certification organization recognized by

the agency, may continue to practice radiography or advanced

diagnostic imaging in the modality in which the person is

currently employed, provided the person does all of the

following:

- (1) On or before July 1, 2023, the person and his or her supervising, collaborating, or directing physicians register with the agency and attest that the person practiced radiography or advanced diagnostic imaging prior to January 1, 2023, and that the person intends to continue this practice.
- (2) The person does not change the scope of his or her current practice.
- (3) The person practices only in collaboration with, or under the supervision or direction of, a physician licensed by the Medical Licensure Commission.
- (b) The agency shall not charge a fee for this registration.

Section 6. The agency may assess a civil penalty for the violation of this act or the violation of any rule adopted by the agency. The proceeds of any civil penalty assessed under this act shall be remitted to the credit of the Radiologic Imaging and Radiation Therapy Fund.

Section 7. This act shall become effective on the first day of the third month following its passage and approval by the Governor, or its otherwise becoming law.
