- (c) Any interest earned on the funds deposited pursuant to subsection (b) shall be annually distributed to the Walker County school system.
- (d) Any proceeds generated from the sale of timber, minerals, or other natural resources of the land, or from the lease of sixteenth section or school indemnity land shall be paid directly to the Walker County Board of Education and deposited into the Walker County Board of Education General Fund.
- (e) It is the intent of the Legislature that this amendment supersede any other provision of this constitution which may be construed as being in conflict with this amendment as it relates to sixteenth section or school indemnity lands in Walker County and the rights, power, and control of the property relating to the sale, lease, or other disposition of the land or the sale of timber, minerals, or other natural resources generated by the land, or any proceeds or interest earned therefrom.

(f) Upon ratification of this amendment, all proceeds realized from the sale, lease, or other disposition of sixteenth section or school indemnity land or the sale of timber, minerals, or other natural resources generated by Walker County sixteenth section or school indemnity lands occurring before ratification of this amendment, and held in trust by the State of Alabama, shall continue to be held in trust and any revenue and interest derived from those transactions shall be paid to the custodian of funds of the Walker County Board of Education.

Section 2. An election upon the proposed amendment shall be held in accordance with Section 284.01 of the Constitution of Alabama of 1901, now appearing as Section 284.01 of the Official Recompilation of the Constitution of Alabama of 1901, as amended, and the election laws of this state.

Section 3. The appropriate election official shall assign a ballot number for the proposed constitutional amendment on the election ballot and shall set forth the following description of the substance or subject matter of the proposed constitutional amendment:

"Relating to Walker County, proposing an amendment to the Constitution of Alabama of 1901, to grant certain sixteenth section lands and school indemnity lands located in that portion of land annexed into the Town of Eldridge by annexation ordinance 48, adopted and filed with the City Clerk of the Town of Eldridge on February 23, 2003, in Walker

County, and held in trust by the state for education purposes 1 2 in Walker County, to the Walker County Board of Education; to 3 authorize the Walker County Board of Education to manage, sell, lease, and control those lands; and to provide for the 4 5 distribution of any proceeds and interest from the sale, lease, or other disposition of the land or the sale of timber, 6 7 minerals, or other natural resources generated by the land.
