WHEREAS, it is with highest commendation that we recognize Lieutenant Greg McGhee and Officer Kris Roney of the Scottsboro Police Department as nominees for the 2018 Alabama Legislative Medal of Honor for Law Enforcement, Alabama's highest law enforcement award for extraordinary courage in the line of duty; and

WHEREAS, while effecting a felony robbery arrest at the intersection of Highway 72 and Snodgrass Road on August 10, 2017, Lieutenant Greg McGhee and Officer Kris Roney witnessed a vehicle that was traveling west on Highway 72 leave the roadway, crash into an embankment, and partially overturn; they drove their patrol cars a short distance, exited their vehicles, and ran toward the flame engulfed vehicle; while Lieutenant McGhee warded off the fire with a fire extinguisher and searched for occupants inside the vehicle, Officer Roney climbed into the overturned vehicle's

broken sunroof and located the driver, Jennifer Nicole
Brownfield, 39, of Scottsboro, Alabama; Officer Roney ensured
there was no one else inside the vehicle before coaxing Ms.
Brownfield to stand, grabbing her from under her arms, and
pulling her out of the burning vehicle; Officer Roney carried
Ms. Brownfield to a safe distance so she would not incur harm
in case the vehicle should explode; Lieutenant McGhee
continued to douse the fire and ensure that no other occupants
were inside the smoke filled vehicle; and
