15 Services has the utmost distinction of being one of the oldest  
16 501 (c) 3 United Way non-profit youth serving agencies in  
17 Mobile County, Alabama, and has expanded its services from  
18 offering a small maternity home for teenage mothers to  
19 implementing educational programs that fulfill the emotional,  
20 social, and physical needs of hundreds of males and females  
21 ranging in ages 9-17 in schools, churches, recreation centers,  
22 and any youth serving agency/organization; and

23 WHEREAS, approximately 8,000 plus youths receive  
24 services free of charge annually; Crittenton Youth Services  
25 equips school staff and administration with bullying  
26 prevention training, teaches the fundamentals of healthy  
27 relationships to seventh and ninth graders, teaches abstinence

1 to eighth and ninth graders, provides family support to youth  
2 and parents, provides education regarding the prevention of  
3 STDs to tenth graders, instructs fourth and fifth graders on  
4 social and emotional competence, and enlists senior  
5 ambassadors in instructing fourth through seventh graders on  
6 bullying prevention skills; local, state, and federal grants,  
7 fundraising efforts, and individual/corporate sponsors help  
8 fund the programs that Crittenton Youth Services provide  
9 throughout Mobile County; and

10 WHEREAS, with an unwavering commitment to excellence  
11 in fulfilling essential services that benefit young people,  
12 our bright hope for the future, and their families, Crittenton  
13 Youth Services reflects immense credit upon Mobile County and  
14 the entire State of Alabama; it is a tremendous privilege to  
15 recognize such a remarkable entity on the occasion of its  
16 100th Anniversary Celebration, which will be commemorated with  
17 a luncheon on April 19, 2018; now therefore,
