3 COMMENDING THE SECURITY FORCE AT THE ALABAMA STATE
4 HOUSE FOR ITS EXEMPLARY SERVICE.

6 WHEREAS, highest commendations and heartiest
7 congratulations are hereby extended to the Security Force at
8 the Alabama State House for exceptional abilities, keen
9 intellect, public service, and unyielding integrity in serving
10 the Legislature and the citizens of Alabama; and

11 WHEREAS, under the leadership of Derek Hamilton, the
12 security for the House of Representatives maintains three
13 year-round security personnel and an additional 15 temporary
14 security officers during the legislative session; for the
15 Senate, Jimmetta Gourdine has the leadership role for three
16 year-round security during officers and an additional 10
17 temporary security officers during the legislative session;

19 WHEREAS, two Alabama state troopers serve the State
20 House on session days and committee meeting days; Dothan
21 Security Incorporated provides the entryway screening at each
22 publicly accessible entry of the Alabama State House; and

23 WHEREAS, the majority of the security detail for the
24 Alabama State House are now serving the public again following
25 a distinguished career in law enforcement; these outstanding

1 officers, with exceptional competence and diligence, are the
2 first line of defense for the employees, elected officials,
3 and citizens who visit the Alabama State House; and

4 WHEREAS, the members of the Security Force have
5 earned respect for their contributions to this state, which is
6 evidenced throughout each legislative session and the
7 estimated value of their service is immeasurable; the Security
8 Force at the Alabama State House has consistently provided
9 this state with invaluable services and are worthy of
10 commendation; now therefore,

11 BE IT RESOLVED BY THE LEGISLATURE OF ALABAMA, BOTH
12 HOUSES THEREOF CONCURRING, That we commend the Security Force
13 at the Alabama State House for its service to the legislative
14 membership and staff and to the citizens of Alabama with
15 outstanding dedication and for exemplifying the high ideals of
16 the law enforcement profession.

17 BE IT FURTHER RESOLVED, That we direct that a copy
18 of this resolution be provided to each member serving on the
19 Security Force for the Alabama State House as an expression of
