8 SYNOPSIS: This bill makes an appropriation of \$169,633  
9 from the State General Fund to the Coalition  
10 Against Domestic Violence for the fiscal year  
11 ending September 30, 2019, requires an operations  
12 plan and an audited financial statement prior to  
13 the release of any funds, and requires quarterly  
14 and end of year performance reports.

20 To make an appropriation of \$169,633 from the State  
21 General Fund to the Coalition Against Domestic Violence for  
22 the fiscal year ending September 30, 2019, to require an  
23 operations plan and an audited financial statement prior to  
24 the release of any funds, and to require quarterly and end of  
25 year performance reports.

26 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

1                   Section 1. For the fiscal year ending September 30,  
2                   2019, there is hereby appropriated to the Coalition Against  
3                   Domestic Violence from the State General Fund the sum of  
4                   \$169,633. In addition, the appropriation made herein shall be  
5                   budgeted and allotted pursuant to the Budget Management Act  
6                   and Article 4 of Title 41 of the Code of Alabama, 1975, and  
7                   specifically Section 41-4-93, Section 41-4-95 and Section  
8                   41-4-96.

9                   Section 2. Prior to the release of any funds  
10                  appropriated under this bill for fiscal year 2019, an  
11                  operations plan for fiscal year 2019 and an audited financial  
12                  statement for all operations during fiscal year 2017 must be  
13                  forwarded to the Director of Finance. It is the intent to  
14                  release fiscal year 2019 funds following receipt of these  
15                  reports.

16                  Section 3. In addition, quarterly reports for fiscal  
17                  year 2019 shall be made to the Director of Finance relating  
18                  actual expenditures and accomplishments. An end of year  
19                  performance report for the fiscal year 2019 shall be made to  
20                  the Director of Finance stating the work accomplished and  
21                  services provided and the costs of accomplishing the work and  
22                  providing the services, citing meaningful measures of program  
23                  effectiveness and costs, as is required for state agencies in  
24                  Code of Alabama 1975, Section 41-19-11. The Director of  
25                  Finance shall forward a copy of all required reports to the  
26                  Legislative Council in a timely manner.

1                                   Section 4. This act shall become effective October  
2           1, 2018.
