8 WHEREAS, it is with highest commendation that we  
9 name that portion of State Road 51 between Midway and Clayton,  
10 in Barbour and Bullock Counties, the Jere L. Beasley Highway;  
11 and

12 WHEREAS, Jere L. Beasley opened a private practice  
13 law firm in Montgomery, Alabama, in 1979, and 35 years later,  
14 it is one of the country's leading firms involved in civil  
15 litigation; the firm has offices in Montgomery and Atlanta;
