9	WHEREAS, the Joint Legislative Task Force on Budget
10	Reform was created by the Legislature during the 2016 First
11	Special Session (Act 2016-480) to examine the structure and
12	design of the state budgeting process and make recommendations
13	for long-term budget and tax system reforms; and
14	WHEREAS, the task force, recreated by Act 2017-63,
15	SJR52, 2017 Regular Session, has held numerous meetings to
16	hear testimony and examine potential policy approaches
17	relating to the expenditures of state government within the
18	General Fund and the existing structure of the state budgeting
19	process; and
20	WHEREAS, due to the diligent work of task force
21	members, the task force has made significant progress in
22	formulating suggested policy changes to the budgeting process
23	which will facilitate thorough review and oversight of state
24	agency spending and ensure that taxpayer dollars are

appropriated in the best possible manner; and

10	Speaker of the House shall fill vacancies created by House
11	members. The President Pro Tempore of the Senate shall fill
12	vacancies created by Senate members.
13	(c) The task force shall evaluate and recommend
14	changes to state budgeting practices including, but not
15	limited to:
16	(1) Adjustments to the budgeting process for the
17	Education Trust Fund and General Fund.
18	(2) Requiring state entities to undergo greater
19	performance and program reviews.
20	(3) Unearmarking funds in order to provide for
21	greater legislative oversight and appropriating flexibility.
22	(4) Reviewing existing state tax credits,
23	deductions, and exemptions that result in the loss of
24	approximately \$4.5 billion in revenue to our state budgets

each year, and creating a policy to ensure that future tax credits effectively provide economic gain to the state.

- (5) Identifying areas to provide tax relief to Alabama families without significantly impacting state budgets.
- (d) The task force shall meet periodically as determined by the co-chairs and shall report its findings, conclusions, and recommendations to the Legislature not later than the 15th legislative day of the 2019 Regular Session, whereupon the task force shall stand dissolved and discharged of any further duties and liabilities.
- (e) Each member of the task force shall be entitled to his or her regular legislative compensation, per diem, and travel expenses for each day he or she attends a meeting of the task force in accordance with Amendment 871 of the Constitution of Alabama of 1901. These payments shall be paid out of any funds appropriated to the use of the Legislature by means of warrants drawn by the state Comptroller on the State Treasury.
