agency spending and ensure that taxpayer dollars are
 appropriated in the best possible manner; and

3 WHEREAS, task force members are commended for their 4 efforts to formulate meaningful budget reform and should be 5 afforded additional time to complete their research and 6 finalize recommendations to the Legislature; and

7 WHEREAS, a Second Interim Report of the Joint 8 Legislative Task Force on Budget Reform was provided as 9 required by Act 2017-63, SJR52, 2017 Regular Session; within 10 that report, the task force requested to be continued and the 11 date for the final report extended until the fifth legislative 12 day of the 2018 Regular Session; now therefore,

BE IT RESOLVED BY THE LEGISLATURE OF ALABAMA, BOTH HOUSES THEREOF CONCURRING, That Act 2017-63, SJR52, 2017 Regular Session, relating to the Joint Legislative Task Force on Budget Reform, is amended and readopted as follows:

17 That a Joint Legislative Task Force on Budget Reform 18 is created to examine the structure and design of the state 19 budgeting process and make recommendations for long-term 20 budget and tax system reforms.

The 10 Speaker of the House shall fill vacancies created by House members. The President Pro Tempore of the Senate shall fill 11 12 vacancies created by Senate members. 13 (c) The task force shall evaluate and recommend 14 changes to state budgeting practices including, but not 15 limited to: 16 (1) Adjustments to the budgeting process for the 17 Education Trust Fund and General Fund. 18 (2) Requiring state entities to undergo greater performance and program reviews. 19 20 (3) Unearmarking funds in order to provide for 21 greater legislative oversight and appropriating flexibility. 22 (4) Reviewing existing state tax credits, 23 deductions, and exemptions that result in the loss of 24 approximately \$4.5 billion in revenue to our state budgets 25 each year, and creating a policy to ensure that future tax credits effectively provide economic gain to the state. 26

(5) Identifying areas to provide tax relief to
 Alabama families without significantly impacting state
 budgets.

4 (d) The task force shall meet periodically as
5 determined by the co-chairs and shall report its findings,
6 conclusions, and recommendations to the Legislature not later
7 than the 15th legislative day of the 2019 Regular Session,
8 whereupon the task force shall stand dissolved and discharged
9 of any further duties and liabilities.

10 (e) Each member of the task force shall be entitled to his or her regular legislative compensation, per diem, and 11 travel expenses for each day he or she attends a meeting of 12 13 the task force in accordance with Amendment 871 of the 14 Constitution of Alabama of 1901. These payments shall be paid 15 out of any funds appropriated to the use of the Legislature by means of warrants drawn by the state Comptroller on the State 16 17 Treasury.
