BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

Section 1. Section 2 of Act 2018-517 of the 2018

Regular Session, now appearing as Section 32-5A-191, effective

July 1, 2013, is repealed.

Section 2. Section 4 of Act 2018-517 of the 2018 Regular Session is amended to read as follows:

- "(a) The provisions of Section 1 and Section 2 shall govern the construction and punishment for any offense defined in Section 1 and Section 2 committed after the effective date of this act, except the provisions of subsection (y) of Section 32-5A-191, Code of Alabama 1975, as amended by Section 1, shall only apply for five years after the effective date of this act.
- "(b) The provisions of Section 1 do not apply to or govern the construction and punishment of any offense

1	committed prior to the effective date of this act. The
2	provisions of Section 2 do not apply to or govern the
3	construction and punishment of any offense committed prior to
4	the effective date of Section 2."
5	Section 3. This act shall become effective
6	immediately following its passage and approval by the
7	Governor, or its otherwise becoming law.
