To amend Section 29-2-40, Code of Alabama 1975, 1 2 relating to the Contract Review Permanent Legislative 3 Oversight Committee, to increase the membership of the board from five to seven members; to clarify that the membership of the committee includes the Chairs of the Senate Finance and 5 Taxation General Fund and Senate Finance and Taxation Education Committees and the Chairs of the House Ways and Means General Fund and House Ways and Means Education 9 Committees; and to authorize a member to continue to serve on 10 the committee until a successor is appointed under certain specific circumstances. 11

BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

Section 1. Section 29-2-40 of the Code of Alabama 1975, is amended to read as follows:

"(a) There is hereby created the Contract Review
Permanent Legislative Oversight Committee. Said The committee
shall be composed of the Chairman Chairs of the Senate Finance
and Taxation General Fund Committee and the Senate Finance and
Taxation Education Committee and the Chairman Chairs of the
House Ways and Means General Fund Committee and the House Ways
and Means Education Committee, and three additional members of
the Senate, to be appointed by the President of the Senate,
and three additional members of the House, to be appointed by
the Speaker of the House.

"(b) A member of the committee may serve on the committee as long as the member retains the office that

1	qualified the member for service or during the term to which
2	the member was appointed and, if reelected to the same house
3	without a break in service to that house, during the
4	succeeding legislative term until a successor is appointed as
5	provided in subsection (a)."
6	Section 2. This act shall become effective on the
