8 SYNOPSIS: Under existing law, the membership of the
9 Contract Review Permanent Legislative Oversight
10 Committee includes the budget committee chair of
11 the Senate, the budget committee chair of the
12 House, and three additional members appointed from
13 each house.

14 This bill would revise the law to clarify
15 that the two budget committee chairs of the Senate
16 and the two budget committee chairs of the House
17 are included on the committee.

18 This bill would also authorize a member to
19 continue to serve on the committee until a
20 successor is appointed under certain specific
21 circumstances.

24 TO BE ENTITLED
25 AN ACT

1 To amend Section 29-2-40, Code of Alabama 1975,
2 relating to the Contract Review Permanent Legislative
3 Oversight Committee, to increase the membership of the board
4 from five to seven members; to clarify that the membership of
5 the committee includes the Chairs of the Senate Finance and
6 Taxation General Fund and Senate Finance and Taxation
7 Education Committees and the Chairs of the House Ways and
8 Means General Fund and House Ways and Means Education
9 Committees; and to authorize a member to continue to serve on
10 the committee until a successor is appointed under certain
11 specific circumstances.

12 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

13 Section 1. Section 29-2-40 of the Code of Alabama
14 1975, is amended to read as follows:

15 "§29-2-40.

16 "(a) There is ~~hereby~~ created the Contract Review
17 Permanent Legislative Oversight Committee. ~~Said~~ The committee
18 shall be composed of the ~~Chairman~~ Chairs of the Senate Finance
19 and Taxation General Fund Committee and the Senate Finance and
20 Taxation Education Committee and the ~~Chairman~~ Chairs of the
21 House Ways and Means General Fund Committee and the House Ways
22 and Means Education Committee, and three additional members of
23 the Senate, to be appointed by the President of the Senate,
24 and three additional members of the House, to be appointed by
25 the Speaker of the House.

26 "(b) A member of the committee may serve on the
27 committee as long as the member retains the office that

1 qualified the member for service or during the term to which
2 the member was appointed and, if reelected to the same house
3 without a break in service to that house, during the
4 succeeding legislative term until a successor is appointed as
5 provided in subsection (a)."

6 Section 2. This act shall become effective on the
7 first day of the third month following its passage and
8 approval by the Governor, or its otherwise becoming law.
