8 SYNOPSIS: This bill makes a supplemental appropriation  
9 from the Education Trust Fund Advancement and  
10 Technology Fund to the State Department of  
11 Education in the amount of \$1,287,807 for the  
12 fiscal year ending September 30, 2019; to the  
13 public institutions of higher education in the  
14 amount of \$73,609,761; and to the Department of  
15 Education, the Board of Trustees of the Alabama  
16 Institute for Deaf and Blind, the Board of Youth  
17 Services School Districts, the Board of Directors  
18 of the Alabama School of Fine Arts, and the Board  
19 of Trustees of the Alabama School of Math and  
20 Science in the amount of \$198,716,398 for the  
21 fiscal year ending September 30, 2019.

1                   To make a supplemental appropriation from the  
2                   Education Trust Fund Advancement and Technology Fund to the  
3                   State Department of Education in the amount of \$1,287,807 for  
4                   the fiscal year ending September 30, 2019, to the public  
5                   institutions of higher education in the amount of \$73,609,761,  
6                   and to the Department of Education, the Board of Trustees of  
7                   the Alabama Institute for Deaf and Blind, the Board of Youth  
8                   Services School Districts, the Board of Directors of the  
9                   Alabama School of Fine Arts, and the Board of Trustees of the  
10                  Alabama School of Math and Science in the amount of  
11                  \$198,716,398 for the fiscal year ending September 30, 2019.

12                  BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

13                         Section 1. In addition to all other appropriations  
14                         heretofore or hereafter made, there is hereby appropriated  
15                         \$1,287,807 from the Education Trust Fund Advancement and  
16                         Technology Fund to the Department of Education for the fiscal  
17                         year ending September 30, 2019. This appropriation shall be  
18                         expended to award grants to local education agencies to  
19                         provide technology tools and professional development services  
20                         to classroom teachers.

21                         Section 2. In addition to all other appropriations  
22                         heretofore or hereafter made, there is hereby appropriated a  
23                         total of \$73,609,761 from the Education Trust Fund Advancement  
24                         and Technology Fund to the public institutions of higher edu-  
25                         cation for the fiscal year ending September 30, 2019. This  
26                         appropriation shall be expended as provided in Section 29-9-4,

20 Section 3. In addition to all other appropriations  
21 heretofore or hereafter made, there is hereby appropriated a

1 total of \$198,716,398 from the Education Trust Fund  
2 Advancement and Technology Fund to the Department of  
3 Education, the Board of Trustees of the Alabama Institute for  
4 Deaf and Blind, the Board of Youth Services School Districts,  
5 the Board of Directors of the Alabama School of Fine Arts, and  
6 the Board of Trustees of the Alabama School of Math and  
7 Science for the fiscal year ending September 30, 2019. This  
8 appropriation shall be expended as provided in Section 29-9-4,  
9 Code of Alabama 1975.

10 Section 4. (a) The Department of Education shall  
11 allocate the funds appropriated herein to the local boards of  
12 education and entities as follows:

4 (b) Notwithstanding any other laws to the contrary,  
5 the funds appropriated to the Department of Education by  
6 subsection (a) of this section shall not be expended without  
7 prior approval of the State Superintendent of Education.

8 (c) The above appropriation for teacher professional  
9 development shall be used to provide technology tools and  
10 professional development services to classroom teachers in an  
11 effort to improve instruction and student learning gains.  
12 Funds shall be allocated to the Alabama Department of  
13 Education to support the Digital Tools for Teachers  
14 Initiative. The Department shall allocate funds through a  
15 grant for local education agencies that will serve an equal  
16 number of teachers per school system through the provision of a  
17 technology tools package. It is the intent of the legislature  
18 that the funds shall be expended only for a tools package that  
19 includes a laptop, wireless tablet, a projector and  
20 professional learning services. The Department shall make a  
21 determination as to which packages are approved for district  
22 purchases.

23 The State Superintendent shall provide a report of  
24 the initiative to the Chair of the House Ways and  
25 Means-Education Committee and the Chair of the Senate

1       Committee on Finance and Taxation-Education no later than  
2       October 1, 2020.

3               Section 5. This act shall become effective  
4       immediately upon its passage and approval by the Governor, or  
5       upon its otherwise becoming law.
