BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

Section 1. The following amendment to the Constitution of Alabama of 1901, as amended, is proposed and shall become valid as a part thereof when approved by a majority of the qualified electors voting thereon and in accordance with Sections 284, 285, and 287 of the Constitution of Alabama of 1901, as amended:

## PROPOSED AMENDMENT

No person may be elected to the Alabama Legislature for more than four full terms. An election to either the Senate or the House of Representatives for at least two years shall be equivalent to the election of a person for a full term in the respective body. Notwithstanding the foregoing, service in the Legislature prior to November 2018, shall not disqualify, in whole or in part, a person from service in the Legislature following that date.

Section 2. An election upon the proposed amendment shall be held in accordance with the provisions of Sections 284 and 285 of the Constitution of Alabama of 1901, now
