26 "(b) (d) The State Department of Education shall
 27 promulgate any necessary rules to provide for the

implementation of this section including, but not limited to, rules providing additional qualifications for employment as school security personnel or school resource officers." Section 2. This act shall become effective on the first day of the third month following its passage and approval by the Governor, or its otherwise becoming law.
