196769-2:g:01/17/2019:EBO-DHC/ebo-hmj 1 2 3 4 5 6 7 Under existing law, Children First Trust 8 SYNOPSIS: 9 Fund programs are required to be funded through a 10 separate appropriation in a separate act. 11 This bill would make an appropriation of 12 \$39,885,565 from the Children First Trust Fund for 13 the fiscal year ending September 30, 2020, to the 14 entities and for the purposes designated in Section 15 41-15B-2.2, Code of Alabama 1975. 16 This bill would provide for the deposit of 17 tobacco settlement revenues into the Children First 18 Trust Fund, would require the State Director of 19 Finance to notify each agency in writing of the 20 amount of each agency's anticipated allocation, 21 would require quarterly allocation to each agency, 22 and would condition allocations upon the receipt of 23 tobacco funds. 24 This bill would provide for the transfer to 25 the State General Fund during fiscal year 2020 that 26 portion of Children First Trust Fund receipts

currently allocated for the State Board of Education.

This bill would make an appropriation of 4 \$48,901,593 from other tobacco settlement funds for 5 the fiscal year ending September 30, 2020.

6 This bill would also make a conditional 7 appropriation and allocation of any additional 8 tobacco revenue on recommendation of the Director 9 of Finance, the Chairman of the House Ways and 10 Means General Fund Committee and the Chairman of 11 the Senate Finance and Taxation-General Fund 12 Committee, and approval of the Governor.

18 To make an appropriation of \$39,885,565 from the Children First Trust Fund for the fiscal year ending September 19 20 30, 2020, to the entities and for the purposes designated in 21 Section 41-15B-2.2, Code of Alabama 1975; to provide for the 22 deposit of tobacco settlement revenues into the Children First 23 Trust Fund; to require written notification of anticipated 24 agency allocations by the State Director of Finance; to 25 require quarterly allocations; to condition allocations on 26 receipt of tobacco revenues; to provide for the transfer to the State General Fund during fiscal year 2020 that portion of 27

Children First Trust Fund receipts currently allocated for the 1 2 State Board of Education; to make an appropriation of \$48,901,593 from other tobacco settlement funds for the fiscal 3 year ending September 30, 2020; and to make a conditional 4 5 appropriation and allocation of additional tobacco revenues upon the recommendation of the Director of Finance, the 6 7 Chairman of the House Ways and Means General Fund Committee and the Chairman of the Senate Finance and Taxation-General 8 Fund Committee, and the approval of the Governor. 9

10 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

Section 1. (a) There is hereby appropriated from the Children First Trust Fund the sum of \$39,885,565 for the fiscal year ending September 30, 2020, to the entities and for the purposes designated in Section 41-15B-2.2, Code of Alabama 15 1975 as follows, per the approved plan of investment for each agency:

4 (b) (1) All tobacco revenues from the tobacco
5 settlement received by the state previously designated for the
6 Children First Trust Fund shall be deposited to the Children
7 First Trust Fund within 30 calendar days of receipt of those
8 tobacco revenues.

9 (2) The Director of Finance shall notify each agency 10 and the Department of Early Childhood Education in writing 11 prior to September 1, 2019, of the dollar amount of the 12 allocation expected to be received by the agency from the 13 Children First Trust Fund in the fiscal year ending September 14 30, 2020.

15 (3) At the beginning of each quarter of the fiscal year ending September 30, 2020, the respective agency shall be 16 17 allocated at least one-fourth of the total amount appropriated and allocated to the agency for that fiscal year when tobacco 18 19 revenues are available for the respective agency. In the event 20 tobacco revenues are not available for the respective agency 21 until later in the fiscal year then the respective agency 22 shall be allocated an equal guarterly allotment for the quarters that funds are available at the beginning of those 23 24 quarters. Such allocation shall be made and be available for 25 expenditure by the agency within five working days of the

1 commencement of the quarter. If additional sums are 2 appropriated or allocated, or both, during the fiscal year, these sums shall be equally allocated to the respective agency 3 among the remaining quarters of the fiscal year or may be 4 5 allocated to the respective agency in one sum if revenues are available. The Department of Early Childhood Education shall 6 7 be notified in writing of all appropriations and allocations 8 from the Children First Trust Fund by the Director of Finance.

9 (4) Allocations from the Children First Trust Fund
10 are conditioned upon the receipt of tobacco revenues.

(c) Allocations received pursuant to Section 1 shall
be expended in accordance with Section 41-15B-2.2, Code of
Alabama 1975.

(d) At the conclusion of the fiscal year, any
remaining sums in the Children First Trust Fund shall remain
in the fund and shall not revert to the General Fund or to any
other fund.

18 Section 2. Notwithstanding any provision of Division 1 of Article 17 of Chapter 10 of Title 41, Code of Alabama 19 1975, any provision of Chapter 15B of Title 41, Code of 20 21 Alabama 1975, or any other provision of law, that portion of Children First Trust Fund receipts currently allocated for the 22 State Board of Education shall be transferred from the 23 24 Children First Trust Fund to the State General Fund during the 25 fiscal year ending September 30, 2020.

26 Section 3. In addition to the appropriation herein 27 above made, there is hereby appropriated from additional to-

bacco settlement funds the sum of \$48,901,593 for the fiscal
 year ending September 30, 2020 to the following entities:

8 Section 4. Any additional tobacco revenues available 9 for the fiscal year ending September 30, 2020, shall be 10 conditionally appropriated, conditioned upon the 11 recommendation of the Director of Finance, the Chairman of the 12 House Ways and Means General Fund Committee and the Chairman 13 of the Senate Finance and Taxation-General Fund Committee, and 14 approval of the Governor.

15 Section 5. The Executive Budget Office and the Director of Finance shall allot funds appropriated from the 16 17 Children First Trust Fund only following the certification by the Commissioner of the Department of Early Childhood 18 19 Education that a plan of investment has been approved for each 20 agency. The Commissioner of the Department of Early Childhood Education shall prescribe the form and format on which each 21 22 agency receiving appropriated funds herein shall submit a plan 23 of investment of said appropriated funds. The plan of

investment shall include, but not be limited to, a minimum of 1 2 four (4) quality assurance items on which a periodic report, as required by the approved plan of investment, is made and as 3 audited by the Examiners of Public Accounts. Quality assurance 4 items shall include the number of children receiving service, 5 an identifiable measure of success of services provided and a 6 7 prioritized standard of successful measures for future plans of investment. It is the intent of the Legislature that the 8 9 Commissioner of the Department of Early Childhood Education 10 shall be responsible for providing a standard of measurement by which a clear determination can be made through operational 11 reporting and audit reporting of a measurable success of funds 12 13 appropriated and invested from the Children First Trust Fund; insure funds appropriated herein are invested in viable 14 15 programs; insure and promote the leverage of appropriated funds herein in every possible manner and coordinated in all 16 17 possible ways the investment of funds by each service provider 18 to insure that no unproductive expenditures or duplication occurs. The Commissioner of the Department of Early Childhood 19 20 Education shall notify legislators representing the area where 21 a grant from the Children First Trust Fund is designated. The 22 notification shall occur ten days before the funds reach the 23 recipient agency.

24 Section 6. The Commissioner of the Department of 25 Early Childhood Education shall report each approved plan of 26 investment to the Joint Interim Legislative Oversight 27 Committee and the Alabama Children's Policy Council. The

1 Commissioner, upon the request of the service agency, may 2 approve an adjusted plan of investment. It is the intent of 3 the Legislature that funds appropriated from the Children 4 First Trust Fund be directed to meet the most immediate needs 5 of children as changing conditions may develop.

6 Section 7. Should any provision of this act be held 7 invalid, the invalidity thereof shall not affect the remaining 8 provisions of the act.

9 Section 8. This act shall become effective
10 immediately upon its passage and approval by the Governor, or
11 upon its otherwise becoming a law.
