6	41-23-214, Code of Alabama 1975, to change the definition of
7	an "unserved area", increase the percentage of project costs
8	that may be funded through the Act, and to broaden the
9	permitted use of other federal and state support, including
10	loans and grants, in projects receiving grants under the Act.
11	BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:
12	Section 1. Sections 41-23-212, 41-23-213 and
13	41-23-214, Code of Alabama 1975, are amended to read as
14	follows:
15	"§41-23-212.
16	For the purposes of this article, the following
17	words have the following meanings:
18	"(1) ADECA. The Alabama Department of Economic and
19	Community Affairs.
20	"(2) END USER. A residential, business,
21	institutional, or government entity that uses broadband
22	services for its own purposes and does not resell such
23	broadband services to other entities. An internet service
24	provider (ISP) and mobile wireless service provider are not an
25	end user for the purposes of this act.

"(2) (4) MINIMUM SERVICE THRESHOLD. A connection to the Internet that provides capacity for transmission at an average speed per customer of at least $\frac{10}{25}$ megabits ($\frac{10}{25}$ Mbps) per second downstream and at least $\frac{10}{25}$ megabits ($\frac{1}{25}$ Mbps) per second upstream.

"(3) (5) RURAL AREA. Any area within this state not included within the boundaries of any incorporated city or town having a population in excess of 25,000 inhabitants, according to the last federal census.

"(4) (6) UNSERVED AREA. Any rural area in which there is not at least one provider of terrestrial broadband service that is either: (1) offering a connection to the Internet meeting the minimum service threshold; or (2) is required, under the terms of the Federal Universal Service Fund or other federal or state grant, to provide a connection to the Internet at speeds meeting the minimum service threshold by March 28, 2023.

"§41-23-213.

"(a) The Director of ADECA may establish and administer the broadband accessibility grant program for the purpose of promoting the deployment and adoption of broadband Internet access services to unserved areas. By June 26, 2018,

the director shall adopt rules and policies to administer the program and begin to accept applications for grants, and shall adopt such rules as may be necessary to meet the future needs of the grant program.

- "(b) The program shall be administered pursuant to policies developed by ADECA in compliance with this article. The policies shall provide for the awarding of grants to non-governmental entities that are cooperatives, corporations, limited liability companies, partnerships, or other private business entities that provide broadband services. Nothing in this article shall expand the authority under state law of any entity to provide broadband service.
- "(c) There is hereby created the Alabama Broadband Accessibility Fund in the State Treasury. The fund is subject to appropriations by the Legislature and gifts, grants, and other donations received by ADECA for the broadband accessibility grant program or fund. ADECA may not spend appropriations for the program for purposes other than those listed in this section. Any monies appropriated to ADECA for broadband grants that are unspent at the end of a fiscal year shall be carried over for use by the program in the next fiscal year. ADECA shall develop rules ensuring that expenses incurred to administer the program must not exceed the lesser of seventhree percent (3%)(7%) of the total amount appropriated for the program in any fiscal year or seven

1	hundred fifty thousand dollars (\$750,000). Moneys in the fund
2	shall be invested by the State Treasurer for the sole benefit
3	of the fund.
4	"(d)(1) Individual grants awarded by ADECA under
5	this section may only be awarded for projects in unserved
6	areas, and may not exceed the lesser of:
7	"a. Twenty <u>Thirty-five</u> percent <u>(35%)</u> of the project
8	costs . ; or
9	"b. One million five hundred thousand dollars
10	(\$1,500,000) for projects that will be capable of transmitting
11	broadband signals at or above the minimum service threshold.
12	"Seven hundred fifty thousand dollars (\$750,000) for
13	projects that will result in transmitting broadband signals at
14	speeds of at least 10 megabits per second of download speed
15	and one megabit per second of upload speed.
16	"c. One million four hundred thousand dollars
17	(\$1,400,000) for projects that will result in transmitting
18	broadband signals at speeds of at least 25 megabits per second
19	of download speed and three megabits per second of upload
20	speed.
21	"(2) Grants may be given to any qualified entity
22	pursuant to subsection (b) that meets the service criteria for
23	expenditures after March 28, 2018.

1	"(3) ADECA shall ensure that not less than 40
2	percent of funds appropriated for grants be utilized in
3	unincorporated areas of the state.
4	"(4) Subject to the limitations in this subsection,
5	grants shall be awarded pursuant to the service criteria
6	developed by ADECA, with priority given to projects that meet
7	any of the following:
8	"a. Seek to leverage grant funds through private
9	investment and extension of existing infrastructure.
10	"b. Serve locations with demonstrated community
11	support, including, but not limited to, documented support
12	from local government.
13	"c. Demonstrate the operator's technical and
14	managerial capabilities to complete the project within two
15	years of the grant.
16	"d. Demonstrate the applicants' necessary financial
17	resources.
18	"e. Are most cost effective and technically
19	efficient in that they propose to serve the highest number of
20	unserved homes, businesses and community anchor points for the
21	least cost and best level of service, emphasizing projects
22	including the highest broadband speeds.
23	"f. Provide material broadband enhancement to
24	hospitals located in rural areas as defined in Section

1	"g. Support local libraries in this state for the
2	purpose of assisting the libraries in offering digital
3	literacy training pursuant to state library and archive
4	guidelines.
5	"(5) For the purposes of awarding grants, ADECA
6	shall take into consideration the average pole attachment
7	rates that a grant applicant charges to an unaffiliated
8	entity, provided that this subdivision (5) shall not apply to
9	a utility as defined under Section 37-4-1 (7)a.
10	"(6) In order to promote the deployment of grant
11	funds in an inclusive manner that is consistent with the
12	racial, gender, geographic, urban, rural, and economic
13	diversity of the state, ADECA may give additional
14	consideration to an applicant that provides documentation that
15	it has been certified by the ADECA Office of Minority Business
16	Enterprise or otherwise as a Disadvantaged Business
17	Enterprise. For projects funded under this act, ADECA shall
18	encourage grant applicants to use vendors and subcontractors
19	that have been certified by the Office of Minority Business
20	Enterprise or that are Disadvantaged Business Enterprises.

ADECA shall include in its report to the Alabama Rural

Broadband Oversight Committee a list of entities certified by

the Office of Minority Business Enterprise and Disadvantaged

Business Enterprises that have been awarded grants since the

1	"(e) The first annual commencement date to submit
2	grant applications shall be by May 27, 2018, and shall be
3	March 1 in each subsequent year. For each fiscal year in which
4	grant funds are available, ADECA shall accept applications
5	within a 150-day <u>90-day</u> grant window after the annual
6	commencement date that it shall establish. Applications for
7	eligible projects will be evaluated according to a scoring
8	system developed by ADECA that incorporates the priorities
9	listed in this section, with grant awards published within 90
10	days after expiration of the filing window. Grant applications
11	shall be published by ADECA on the Internet at the end of the
12	filing window, and existing service providers shall have 30
13	<u>business</u> days from the date of publication to file objections
14	to the eligibility of a proposed project. ADECA shall address
15	any objections within 30 days of submission and shall make any
16	appropriate changes to grant awards based on a finding of
17	ineligibility resulting from such protest. Subject to such
18	protest procedure, grants issued by ADECA shall be conditioned
19	upon compliance with the terms of the grant but shall not
20	otherwise be revocable. Providers' grants shall be paid within
21	30 days upon ADECA receiving written certification of the
22	completion of the project and evidence of compliance with the
23	terms of the grant as prescribed by ADECA.

"(f) Grants shall be conditioned on project

completion within two years of awarding of the grant. If a

1	recipient fails to complete a project within the two-year
2	deadline due to reasons other than delay caused by a
3	government entity, ADECA may revoke the grant in its entirety
4	and rededicate the funds to a new recipient.
5	"(g) ADECA shall condition the release of any grant
6	funds awarded under this chapter on:
7	"(1) the progressive completion, as measured on not
8	more than a quarterly basis, of the approved project; and
9	"(2) operational testing, when possible, to confirm
10	the level of service proposed in the grant application. Such
11	regulations shall not exceed in degree or differ in kind from
12	testing and reporting requirements imposed on the grant
13	recipient by the Federal Communications Commission, as
14	adjusted for the service specifications in the ADECA grant
15	agreement.
16	" $\frac{(g)}{(h)}$ Notwithstanding any other provision of this
17	section, eligible projects shall include projects any of the
18	<pre>following:</pre>
19	"(1) Projects to serve unserved areas in which the
20	grant applicant is either or both: (i) an existing or future
21	service provider which has or will receive support through
22	federal universal service funding programs designed
23	specifically to encourage broadband deployment in an area
24	without broadband access; or (ii) an existing or future
25	service provider which has or will receive other forms of

Τ	<u>federal or state financial support or assistance, such as a</u>
2	grant or loan from the United States Department of
3	Agriculture; provided, however, that any award of state funds
4	under this act, when combined with other forms of state or
5	federal support or assistance dedicated to the project, other
6	than interest-bearing loans, may not exceed sixty percent
7	(60%) of the total project costs. Nothing in this section
8	shall prohibit a grant applicant who has not previously
9	received any federal or state funds, grants, or loans for
10	broadband deployment from applying for and receiving grant
11	funds under this act. that have received funds through other
12	federal universal service funding programs designed
13	specifically to encourage broadband deployment in an area
14	without broadband access in an amount not exceeding 50 percent
15	of the total project cost; provided, however, that any award
16	of state funds may only be utilized to either (i) fund project
17	components that extend beyond the specifications supported by
18	the federal funding, the eligible components being an
19	extension of service to unserved rural areas not otherwise
20	served by the federally supported project, or (ii) ensure that
21	areas being served by the federal funding at speeds less than
22	25 megabits per second of download speed and three megabits
23	per second of upload speed will, in fact, receive faster
24	speeds of not less than 25 megabits per second of download
25	speed and three megabits per second of upload speed. Grants

issued under this subsection shall not exceed 40 percent of

total grant funding, with such grants not exceeding 20 percent

of total project costs.

"(2) Middle Mile Projects, where the applicant demonstrates that the project will connect other service providers eligible for grants under this section with broadband infrastructure further upstream in order to enable such providers to offer broadband service to end users; provided that eligible projects under this subdivision may include projects in (i) an unserved area or (ii) a rural area that does not meet the definition of an unserved area but otherwise meets the requirements of this section, for which the grant applicant demonstrates, by specific evidence, the need for greater broadband speeds, capacity, or service which is not being offered by an existing service provider.

"(3) Projects to provide broadband service to a specific hospital, public school, public safety, or economic development site in a rural area that does not meet the definition of an unserved area but otherwise meets the requirements of this section, for which the grant applicant demonstrates, by specific evidence, the need for greater broadband speeds, capacity, or service which is not being offered by an existing service provider.

1	"(4) Grants issued under subdivisions (2) and (3)
2	shall not exceed forty percent (40%) of the total funds
3	appropriated for grants on an annual basis.

5	"(a) There is created the Alabama Rural Broadband
6	Oversight Committee. The oversight committee shall consist of
7	the Chair of the House Ways and Means Education Committee or
8	his or her designee, the Chair of the Senate Finance and
9	Taxation Education Committee or his or her designee, two
10	members appointed by the Speaker of the House of
11	Representatives, two members appointed by the President Pro
12	Tempore of the Senate, and the Director of ADECA or his or her
13	designee. The oversight committee shall meet at least
14	annually, provide general oversight of the implementation of
15	the article, and recommend further statutory changes to
16	promote rural broadband development.

11	application to any person or circumstance is held invalid, the
12	invalidity does not affect other provisions or applications of
13	this act which can be given effect without the invalid
14	provision or application, and to this end, the provisions of
15	this act are severable.
16	Section 4. This act shall become effective
17	immediately following the passage and approval of this act by

the Governor, or its otherwise becoming law.
