## 2 ENROLLED, An Act,

To propose an amendment to the Constitution of Alabama of 1901, relating to Lamar County, to authorize the Legislature to place the judge of probate on a salary and provide for the fees, commissions, allowances, and percentages collected by the judge of probate to be deposited in the county treasury. The amendment would ratify and confirm prior acts and any salary paid to the judge of probate effective for the term which commenced in January 1989.

BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

Section 1. The following amendment to the Constitution of Alabama of 1901, is proposed and shall become valid as a part of the Constitution when all requirements of this act are fulfilled:

## 16 PROPOSED AMENDMENT

In Lamar County, the Legislature, by general or local law, may place the judge of probate on a salary and provide for the fees, commissions, allowances, and percentages collected by the judge of probate to be paid into the county treasury from which his or her salary is paid. This amendment is retroactive to the term of office of the judge of probate which commenced in January 1989. Any local law applicable to Lamar County placing the judge of probate on a salary is ratified and confirmed and any salary paid to the judge of

2	any salary accepted by the judge of probate by agreement, is
3	ratified and confirmed.
4	Section 2. An election upon the proposed amendment
5	shall be held in accordance with Section 284 and Section
6	284.01 of the Constitution of Alabama of 1901, now appearing
7	as Section 284 and Section 284.01 of the Official
8	Recompilation of the Constitution of Alabama of 1901, as
9	amended, and the election laws of this state.
10	Section 3. The appropriate election official shall
11	assign a ballot number for the proposed constitutional
12	amendment on the election ballot and shall set forth the
13	following description of the substance or subject matter of
14	the proposed constitutional amendment:
15	"Relating to Lamar County, to authorize the
16	Legislature to place the judge of probate on a salary and
17	provide for the fees, commissions, allowances, and percentages
18	collected by the judge of probate to be deposited in the
19	county treasury. The amendment would ratify and confirm prior
