3 Relating to Lauderdale County; to propose an
4 amendment to the Constitution of Alabama of 1901, to repeal
5 Amendments 819 and 918 to the Constitution of Alabama of 1901,
6 now appearing as Section 4.10, Local Amendments, Lauderdale
7 County, Official Recompilation of the Constitution of Alabama
8 of 1901, as amended, which provide for the Lauderdale County
9 Judicial Commission, created for the purpose of nominating to
10 the Governor persons for appointment to fill a vacancy in the
11 office of the judge of the circuit court or the office of the
12 judge of the district court in Lauderdale County.

13 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

14 Section 1. The following amendment to the
15 Constitution of Alabama of 1901, is proposed and shall become
16 valid as a part of the Constitution when all requirements of
17 this act are fulfilled:

18 PROPOSED AMENDMENT

19 Amendments 819 and 918 to the Constitution of
20 Alabama of 1901, now appearing as Section 4.10, Local
21 Amendments, Lauderdale County, Official Recompilation of the
22 Constitution of Alabama of 1901, as amended, which provide for
23 the Lauderdale County Judicial Commission, created for the
24 purpose of nominating to the Governor persons for appointment
25 to fill a vacancy in the office of the judge of the circuit

1 court or the office of the judge of the district court in
2 Lauderdale County, are repealed.

3 Section 2. An election upon the proposed amendment
4 shall be held at the 2020 General Election in accordance with
5 Sections 284 and 284.01 of the Constitution of Alabama of
6 1901, now appearing as Sections 284 and 284.01 of the Official
7 Recompilation of the Constitution of Alabama of 1901, as
8 amended, and the election laws of this state.

9 Section 3. The appropriate election official shall
10 assign a ballot number for the proposed constitutional
11 amendment on the election ballot and shall set forth the
12 following description of the substance or subject matter of
13 the proposed constitutional amendment:

14 "Proposing a local constitutional amendment relating
15 to Lauderdale County, to repeal Amendments 819 and 918 to the
16 Constitution of Alabama of 1901, now appearing as Section
17 4.10, Local Amendments, Lauderdale County, Official
18 Recompilation of the Constitution of Alabama of 1901, as
19 amended, which provide for the Lauderdale County Judicial
20 Commission, created for the purpose of nominating to the
21 Governor persons for appointment to fill a vacancy in the
22 office of the judge of the circuit court or the office of the
23 judge of the district court in Lauderdale County.
