2	registered as provided by law, shall have the right to vote in
3	the county of his or her residence. The Legislature may
4	prescribe reasonable and nondiscriminatory requirements as
5	prerequisites to registration for voting. The Legislature
6	shall, by statute, prescribe a procedure by which eligible
7	citizens can register to vote.

- "(b) No person convicted of a felony involving moral turpitude, or who is mentally incompetent, shall be qualified to vote until restoration of civil and political rights or removal of disability.
- "(c) The Legislature shall by law provide for the registration of voters, absentee voting, secrecy in voting, the administration of elections, and the nomination of candidates."

Section 2. An election upon the proposed amendment shall be held in accordance with Sections 284 and 285 of the Constitution of Alabama of 1901, now appearing as Sections 284 and 285 of the Official Recompilation of the Constitution of Alabama of 1901, as amended, and the election laws of this state.

Section 3. The appropriate election official shall assign a ballot number for the proposed constitutional amendment on the election ballot and shall set forth the
