6 "(c) Notwithstanding subsection (b), a delivery 7 service permittee or an employee or independent contractor of 8 a delivery service permittee may transport and deliver 9 alcoholic beverages to a resident who is at least 21 years of 10 age in the state in accordance with Section 28-3A-3.1.

11 "(c) (d) Any violation of subsection (a) of this
12 section (b) shall be a misdemeanor, punishable as provided in
13 paragraph <u>subdivision</u> (1) of subsection (b) of Section

"(d) All laws or parts of law which conflict or are

Section 2. Section 28-3A-3.1 is added to the Code of Alabama 1975, to read as follows:

(a) Notwithstanding any other provision of this
title, any person, limited liability company, or partnership
that is registered to do business in this state, regardless of
the residency of the ownership of the entity, may apply for
and be issued a delivery service permit that authorizes the
permittee to deliver alcoholic beverages from a retailer
licensed to sell alcoholic beverages for off-premises

1 consumption to a resident in the state who is at least 21
2 years of age for the resident's personal use and not for
3 resale.

4 (b) In order to receive a permit, the applicant for
5 a delivery service permit shall do all of the following:

6 (1) File an application with the Alcoholic Beverage 7 Control Board.

(2) Pay a filing fee of one hundred dollars (\$100).

9 (3) Provide to the board a sample contract it will 10 enter into with a licensed retailer for the delivery of 11 alcoholic beverages.

(c) A delivery service permittee:

(1) May contract with any retailer licensed to sell
 alcoholic beverages for off-premises consumption for the
 purpose of delivering alcoholic beverages, including liquor,
 beer, and wine.

17 (2) May use its own employees or independent
18 contractors who are at least 21 years of age, to deliver
19 alcoholic beverages under this section.

(3) May take orders by telephone, Internet, or by
other electronic means for the sale and delivery of alcoholic
beverages under this section.

(4) May deliver only sealed containers of alcohol.

(5) Shall obtain from the customer an attestation
that he or she is at least 21 years of age at the time the
order is placed.

(6) For any shipping container of which it is not
 readily apparent that it contains alcoholic beverages, shall
 stamp, print, or label on the outside of the shipping
 container the words: "CONTAINS ALCOHOL: Must be delivered to a
 person 21 years of age or older."

6 (7) Shall require the customer, at the time of 7 delivery, to provide photo identification verifying he or she 8 is at least 21 years of age and sign for the delivery.

9 (8) Shall report, at the direction of the board, the 10 total amount of alcoholic beverages directly shipped to 11 residents in the state during the preceding calendar year.

12 (9) Shall collect and properly remit all state and
13 local sales or use taxes and excise taxes due on sales to
14 Alabama residents.

(10) Shall permit the board or the Department of
 Revenue to perform an audit of the permittee's records upon
 request.

(11) Shall be deemed to have consented to the
jurisdiction of the board or any law enforcement agency and
the Alabama courts concerning enforcement of this section and
any related laws or rules.

(d) Any individual applying for a delivery service
permit under this section must be 21 years of age or older and
must not have been convicted of a felony.

(e) A delivery service permittee may renew its
 permit with the board by paying annually a renewal fee of

1 fifty dollars (\$50) and providing the board a true copy of its 2 current permit.

3 (f) The board may enforce the requirements of this 4 section to suspend or revoke a delivery service permit by the 5 same administrative proceedings that apply to alcoholic 6 beverage licenses, and the board may accept payment of a fine 7 in lieu of suspension or revocation, such payments to be 8 determined by rule adopted by the board.

9 (g) The board may adopt rules pursuant to the 10 Alabama Administrative Procedure Act to implement this 11 section.

12 Section 3. This act shall become effective on the 13 first day of the third month following its passage and 14 approval by the Governor, or its otherwise becoming law.
