8 SYNOPSIS: This bill would relate to any Class 3
9 municipality organized under Act 618 of the 1973
10 Regular Session and would further provide for the
11 salary of the city council and mayor.

14 TO BE ENTITLED
15 AN ACT

17 Relating to any Class 3 municipality organized under
18 Act 618 of the 1973 Regular Session (Acts 1973, p. 879),
19 providing for the mayor-council form of government in certain
20 municipalities having a certain population according to the
21 1970 or any subsequent federal decennial census; to amend
22 Sections 3.05 and 4.04 of Act 618, as last amended by Act
23 95-533 of the 1993 Regular Session (Acts 1995, p. 1080), to
24 further provide for the salary of the city council and mayor.
25 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

1 Section 1. This act shall apply only to any Class 3
2 municipality organized under Act 618 of the 1973 Regular
3 Session (Acts 1973, p. 879).

4 Section 2. Sections 3.05 and 4.04 of Act 618 of the
5 1973 Regular Session of the Legislature, as amended, are
6 amended to read as follows:

7 "Section 3.05. Compensation - Commencing with the
8 ~~1995~~ 2019 term, the Council shall receive ~~such~~ an annual
9 salary as the Council ~~may~~, by resolution or by ordinance, may
10 prescribe. ~~Such~~ The salary and the manner in which it is to be
11 paid, shall be established by the Council. In no event shall
12 the Council set the annual salary of the Council below ~~eight~~
13 ~~thousand five hundred dollars (\$8,500)~~ twenty thousand dollars
14 (\$20,000) or above ~~eighteen thousand dollars (\$18,000)~~ thirty
15 thousand dollars (\$30,000) per year.

16 "Section 4.04. Compensation - Commencing with the
17 ~~1995~~ 2019 term, the Mayor shall receive ~~such~~ an annual salary
18 as the Council ~~may~~, by resolution or ordinance, may prescribe.
19 ~~Such~~ The salary and the manner in which it is to be paid,
20 shall be established by the Council. In no event shall the
21 Council set the annual salary of the Mayor below ~~fifty~~
22 ~~thousand dollars (\$50,000)~~ one hundred twenty-five thousand
23 dollars (\$125,000) or above ~~ninety-five thousand dollars~~
24 ~~(\$95,000)~~ one hundred fifty thousand dollars (\$150,000) per
25 year."

26 Section 3. This act shall become effective beginning
27 the next term of office of the city council and mayor of the

1 municipality following its passage and approval by the
2 Governor, or its otherwise becoming law.
