6 ENROLLED, An Act,

7 Relating to Morgan County; to provide for the  
8 allocation and expenditure of money received from the  
9 Tennessee Valley Authority and distributed to Morgan County  
10 pursuant to Act 2010-135, 2010 Regular Session (Acts 2010, p.  
11 190), for certain fiscal years; and to ratify and confirm any  
12 payments made pursuant to Act 2014-109 of the 2014 Regular  
13 Session (Acts 2014, p. 186).

14 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

15 Section 1. Notwithstanding any other provision of  
16 law, after the allocation of the proceeds pursuant to Act  
17 2013-199 of the 2013 Regular Session, any remaining proceeds  
18 allocated to Morgan County pursuant to Act 2010-135, 2010  
19 Regular Session (Acts 2010, p. 190), from the in-lieu-of-taxes  
20 payments made by the Tennessee Valley Authority shall be  
21 distributed as follows:

22 (1) For the fiscal years beginning October 1, 2018,  
23 October 1, 2019, October 1, 2020, and October 1, 2021, the  
24 remaining proceeds up to a total of three hundred thirty  
25 thousand dollars (\$330,000) each year shall be distributed to

1 the Community Foundation of Greater Decatur, Inc., to be  
2 distributed by the community foundation based on  
3 recommendations for expenditure from the member representing  
4 each House of Representatives District and the Senate District  
5 comprised of territory in Morgan County as follows: The funds  
6 shall be divided into two shares, with one share to be  
7 expended in the Senate District and one share to be expended  
8 in the House of Representatives Districts based on the  
9 approximate population of each House of Representatives  
10 District in Morgan County as a percentage of the total  
11 population of Morgan County.

12 (2) Any distributions pursuant to subdivision (1)  
13 shall be at the sole discretion of the Community Foundation of  
14 Greater Decatur, Inc.

15 (3) After payment of the above distribution each  
16 year, any remainder shall be distributed each year to the  
17 Morgan County legislative delegation office.

18 Section 2. Any payments made pursuant to Act  
19 2014-109 of the 2014 Regular Session (Acts 2014, p. 186) are  
20 ratified and confirmed.

21 Section 3. This act shall become effective  
22 immediately following its passage and approval by the  
23 Governor, or its otherwise becoming law.
