8 SYNOPSIS: This bill would add certain named chemical 9 compounds of Tianeptine to Schedule II of the 10 controlled substances list. Possession, 11 distribution, and trafficking of these compounds 12 would be deemed unlawful and violators would be 13 subject to criminal penalties for distribution.

Placing Tianeptine on Schedule II would allow for future legal possession and use by medical prescription if Tianeptine ever were to be approved for human medical use by the FDA.

Amendment 621 of the Constitution of Alabama 18 19 of 1901, now appearing as Section 111.05 of the 20 Official Recompilation of the Constitution of 21 Alabama of 1901, as amended, prohibits a general 22 law whose purpose or effect would be to require a 23 new or increased expenditure of local funds from 24 becoming effective with regard to a local 25 governmental entity without enactment by a 2/3 vote 26 unless: it comes within one of a number of 27 specified exceptions; it is approved by the

affected entity; or the Legislature appropriates funds, or provides a local source of revenue, to the entity for the purpose.

The purpose or effect of this bill would be to require a new or increased expenditure of local funds within the meaning of the amendment. However, the bill does not require approval of a local governmental entity or enactment by a 2/3 vote to become effective because it comes within one of the specified exceptions contained in the amendment.

16 To amend Section 20-2-25, Code of Alabama 1975, 17 relating to Schedule II of the controlled substances list, to 18 include additional controlled substances; and in connection therewith would have as its purpose of effect the requirement 19 20 of a new or increased expenditure of local funds within the 21 meaning of Amendment 621 of the Constitution of Alabama of 22 1901, now appearing as Section 111.05 of the Official 23 Recompilation of the Constitution of Alabama of 1901, as 24 amended.

25 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

26 Section 1. Section 20-2-25, Code of Alabama 1975, is 27 amended to read as follows: "\$20-2-25.
"The controlled substances listed in this section
are included in Schedule II:
"(1) Any of the following substances, except those
narcotic drugs listed in other schedules, whether produced

directly or indirectly by extraction from substances of vegetable origin or independently by means of chemical synthesis or by combination of extraction and chemical synthesis:

10 "a. Opium and opiate and any salt, compound,11 derivative, or preparation of opium or opiate.

12 "b. Any salt, compound, isomer, derivative, or 13 preparation thereof which is chemically equivalent or 14 identical with any of the substances referred to in paragraph 15 a, but not including the isoquinoline alkaloids of opium.

"c. Opium poppy and poppy straw.

17 "d. Coca leaves and any salt, compound, derivative, 18 or preparation of coca leaves and any salt, compound, 19 derivative, or preparation thereof which is chemically 20 equivalent or identical with any of these substances, but not 21 including decocainized coca leaves or extractions which do not 22 contain cocaine or ecgonine.

<u>"e. Tianeptine and any salt, sulfate, free acid, or</u>
<u>other preparation of Tianeptine, and any salt, sulfate, free</u>

2 Section 2. Although this bill would have as its 3 purpose or effect the requirement of a new or increased expenditure of local funds, the bill is excluded from further 4 5 requirements and application under Amendment 621, now appearing as Section 111.05 of the Official Recompilation of 6 the Constitution of Alabama of 1901, as amended, because the 7 bill defines a new crime of amends the definition of an 8 existing crime. 9

10 Section 3. This act shall become effective on the 11 first day of the third month following its passage and 12 approval by the Governor, or its otherwise becoming law.
