3 To make an appropriation of \$947,147 from the Education Trust Fund to Talladega College in Talladega, 4 5 Alabama for the support and maintenance of the educational 6 program of the institution, for the fiscal year ending 7 September 30, 2021; to provide that the appropriation is subject to certain provisions of the Code of Alabama 1975; to 8 9 require an operations plan and an audited financial statement 10 prior to the release of any funds; and to require an end of 11 year report.

12 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

13 Section 1. There is hereby appropriated the sum of 14 \$947,147 from the Education Trust Fund to Talladega College in 15 Talladega, Alabama for the support and maintenance of the 16 educational program of the institution, for the fiscal year 17 ending September 30, 2021.

Section 2. The above appropriation is made for the 18 19 support of public education in Alabama and for the support and 20 maintenance of the above program. The appropriation shall be subject to the provisions, terms, conditions, and limitations 21 22 of the Budget and Financial Control Act, Code of Alabama 1975, 23 Sections 41-4-80 et seq.; the provisions of The Budget Management Act of 1976, Code of Alabama 1975, Sections 41-19-1 24 25 et seq.; and any other provisions of this act.

Section 3. (a) Prior to the release of any funds
 appropriated under this act the following reports shall be
 submitted:

4 (1) An operations plan for the fiscal year 2021,
5 including goals and measurable performance indicators, shall
6 be submitted to and approved by the Director of Finance, as
7 provided for state agencies in Code of Alabama 1975, Section
8 41-19-10.

9 (2) An audited financial statement for all
10 operations during the fiscal year 2019.

(b) It is the intent that funds appropriated for
fiscal year 2021 shall be released by the Director of Finance
following receipt of the above reports.

14 (c) In addition, quarterly reports shall be made to 15 the Director of Finance relating actual expenditures and 16 accomplishments to planned expenditures and accomplishments. 17 An end of year performance report for the fiscal year 2021 shall be made to the Director of Finance stating the work 18 accomplished and the services provided and the costs of 19 accomplishing the work and providing the services, citing 20 21 meaningful measures of program effectiveness and costs, as is 22 required for state agencies in Code of Alabama 1975, Section 23 41-19-11.

(d) The Director of Finance shall forward a copy of
 all required reports to the Legislative Council in a timely
 manner.

Section 4. This act shall become effective October
1, 2020.
