7	the Enterprise City Council; in 1989, she was appointed as the
8	first female Mayor of Enterprise; in 1990, she was chosen as
9	Enterprise's Woman of the Year; and
10	WHEREAS, she was a lifelong member of First Baptist
11	Church, a member of the Phyllis Talmadge Sunday School Class,
12	one of the first members of the Twentieth Century Misses
13	Chautauqua Club, and an active member of the Twentieth Century
14	Chautauqua Club; also, she was a strong supporter of the
15	Enterprise Recreational Center; and
16	WHEREAS, Mrs. Thompson served on various boards and
17	committees; she served as the Board President of the YMCA from
18	1983 to 1984, and she served on the Coffee County Family
19	Services Board as well; and
