5 ESTABLISHING A TASK FORCE TO STUDY THE DIRECT  
6 SHIPMENT OF WINE.

7  
8 BE IT RESOLVED BY THE LEGISLATURE OF ALABAMA, BOTH  
9 HOUSES THEREOF CONCURRING, That there is created a Task Force  
10 to Study the Direct Shipment of Wine.

11 (a) The task force shall consist of the following  
12 members:

13 (1) Two members appointed by the President Pro  
14 Tempore of the Senate, one of whom shall represent a licensed  
15 wine manufacturer in the state, and one of whom shall  
16 represent a licensed wine distributor in the state.

17 (2) Two members appointed by the Speaker of the  
18 House of Representatives, one of whom shall represent a  
19 licensed wine retailer in the state, and one of whom shall  
20 represent a shipping and delivery business.

21 (3) Two members of the Senate, one of whom shall be  
22 a member of the minority party, appointed by the President Pro  
23 Tempore of the Senate.

1           (4) Two members of the House of Representatives, one  
2 of whom shall be a member of the minority party, appointed by  
3 the Speaker of the House of Representatives.

4           (5) A representative of the Alcoholic Beverage  
5 Control Board, appointed by the board.

6           (b) The appointing authorities shall coordinate  
7 their appointments to assure the task force membership is  
8 inclusive and reflects the racial, gender, geographic, urban,  
9 rural, and economic diversity of the state.

10          (c) The first meeting of the task force shall be  
11 called by the President Pro Tempore of the Senate and the  
12 Speaker of the House of Representatives. At the first meeting,  
13 the task force shall elect a chair and vice-chair.

14          (d) The task force shall examine other states' laws  
15 regarding the direct shipment of alcoholic beverages from  
16 producers or retailers to customers, particularly under  
17 circumstances where other states use a 3-tier system of  
18 regulating alcoholic beverages, and how direct shipment of  
19 wine would impact Alabama's existing regulatory structure and  
20 its licensed manufacturers, distributors, and retailers under  
21 the 3-tier system and the benefits of authorizing direct  
22 shipment.

23          (e) The goal of the task force is to determine  
24 whether the direct shipment of wine would benefit the state as

1 a whole, while protecting current businesses and ensuring that  
2 alcohol is delivered in a responsible manner.

3 (f) The task force shall hold a minimum of two  
4 public hearings to receive input from the public and from  
5 individuals and businesses involved in the manufacturing,  
6 distribution, and retail sale of wine and from common carriers  
7 and other businesses involved in shipping and delivery.

8 (g) Each legislative member of the task force shall  
9 be entitled to his or her regular legislative compensation,  
10 per diem, and travel expenses for each day of attendance at a  
11 meeting of the task force in accordance with Amendment 871 of  
12 the Constitution of Alabama of 1901.

13 (h) Not later than December 1, 2020, the task force  
14 shall report its findings, including any legislative  
15 recommendations, to the Legislature. Upon submission of its  
16 report, the task force shall be dissolved.
