Prison Oversight Committee and to provide for additional 1 2 reporting requirements; and to amend Section 14-3-13, Code of Alabama 1975, to revise the correctional officer oath of 3 office. 4 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA: 5 Section 1. Section 14-1-21 is added to the Code of 6 7 Alabama 1975, to read as follows: §14-1-21. 8 9 (a) In addition to any reporting requirements under 10 existing law, the Alabama Department of Corrections shall provide to the Joint Legislative Prison Oversight Committee 11 quarterly reports that include all of the following: 12 13 (1) A report containing statistical data that would 14 allow the Legislature to assess the size or composition of the 15 inmate population. (2) A report containing statistical data that would 16 17 allow the Legislature to assess the general status of 18 correctional officer staffing levels. 19 (3) A report containing statistical data, by sex, of 20 inmate participation in educational, vocational, religious, or 21 reentry programs. 22 (4) A list of all litigation filed during the 23 quarter involving the department, or any of its employees that 24 relates to performance of his or her employment, to include 25 the case style, case number, court, date of filing, and the amount of money paid by the department to defend such 26 27 litigation.

(5) A report containing statistical data of all 1 2 occurrences of sexual abuse and sexual victimization of inmates in a correctional facility that are reported to the 3 department. For each incident, the department shall designate 4 5 whether the investigation is pending or complete. If the investigation is complete, the department shall provide 6 7 whether the incident was found to be substantiated, unsubstantiated, or unfounded. 8

9 (6) A report containing statistical data on the 10 number, manner, and cause of inmate deaths occurring in a 11 correctional facility, including the results of any autopsy 12 provided to the department by a third party.

13 (7) A report containing statistical data of cell
14 phones or other electronic devices, weapons, and controlled
15 substances recovered within a correctional facility.

16 (b) Nothing in this section shall require the 17 department to disclose sensitive security information, 18 information from open criminal investigative files, material protected by attorney-client privilege, executive privilege, 19 20 work product doctrine or that reveals legal strategy in 21 pending litigation, information prepared for or filed under 22 seal in any court proceeding, or information otherwise 23 protected from disclosure by law.

(c) This report shall be made publicly available on
the department's website within 10 days of its delivery to the
joint oversight committee.

Section 2. Section 14-3-13, Code of Alabama 1975, is
 amended to read as follows:

"§14-3-13.

4 "Every <u>correctional</u> officer and guard shall, before
5 entering on <u>performing</u> the duties of his <u>or her</u> office, <u>shall</u>
6 take and subscribe before <u>some</u> <u>an</u> officer authorized to
7 administer oaths, the following oath:

""I, , do solemnly swear (or affirm, as the 8 9 case may be) that I will support the Constitution of the 10 United States and the Constitution of the State of Alabama, so long as I remain a citizen thereof; that I will faithfully 11 12 execute and discharge all the duties required of me as 13 (designating the office), and observe all the rules and 14 regulations prescribed of the department for the government 15 care and rehabilitation of convicts prisoners, so far as concerns my office; and will, in no case, ill treat or abuse 16 17 any convict prisoner under my charge or control, nor inflict 18 upon him or her any other or greater punishment than may be prescribed by said rules and the law or the regulations of the 19 20 department. So help me God."

21 Section 3. Section 1 of this act shall become 22 effective on the first day of the third month following its 23 passage and approval by the Governor, or its otherwise 24 becoming law; Section 2 of this act shall become effective 25 immediately following its passage and approval by the 26 Governor, or its otherwise becoming law.
