8	SYNOPSIS:	Under existing law, when an employer and
9		employee are subject to the workers' compensation
10		laws, an employee who is disabled or killed as a
11		result of an occupational disease is entitled to
12		compensation.
13		Also under existing law, an occupational
14		disease is not considered to include a mental
15		disease or disorder, including post-traumatic
16		stress disorder, unless a physical injury
17		accompanies the mental disease or disorder.
18		This bill would provide that a law
19		enforcement officer or firefighter employed by a
20		municipality, county, or fire district and
21		diagnosed with post-traumatic stress disorder would
22		be reimbursed for certain co-payments for treatment

Relating to counties, municipalities, and fire districts; to provide that a law enforcement officer or firefighter employed by a county, municipality, or fire district and diagnosed with post-traumatic stress disorder would be reimbursed for certain co-payments for treatment under certain conditions; to require counties, municipalities, and fire districts to maintain certain disability insurance coverage for law enforcement officers and firefighters who are unable to return to work as a result of post-traumatic stress disorder under certain conditions; and to exclude certain payments and reimbursement from state income taxation.

BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

Section 1. (a) For the purposes of this act, the following terms shall have the following meanings:

(1) FIREFIGHTER. A full-time paid firefighter certified by the Alabama Fire College and employed by a municipality, county, or fire district established under Chapter 89 of Title 11, Code of Alabama 1975.

1 (2) OFFICER. A law enforcement officer certified by 2 the Alabama Peace Officers' Standards and Training Commission 3 and employed full time by a municipality or county.

- (3) POST-TRAUMATIC STRESS DISORDER (PTSD). A mental health condition that meets the diagnostic criteria in the Diagnostic and Statistical Manual of Mental Disorders, Fifth Edition, published by the American Psychiatric Association.
- (4) SPECIFIC EVENT. An isolated and extraordinarily traumatic event that involves an officer or firefighter acting within the line and scope of duty and that includes the officer or firefighter satisfying either of the following:
- a. Witnessing or being directly engaged in actions resulting in the death of an individual or individuals on the scene of the event.
- b. Witnessing or being directly engaged in actions, during or in rapid emergency response immediately after the occurrence, that resulted in injuries of such an extraordinary and severe nature that they lead directly to the death of an individual or individuals due to the injuries on the way to, or no more than 24 hours after, reaching a hospital for initial treatment.
- (b) (1) A county, municipality, or fire district shall reimburse an officer or firefighter employed by the county, municipality, or fire district for any co-payment paid by or on behalf of the officer or firefighter for the treatment, including counseling or therapy, of PTSD or shall maintain sufficient coverage to provide any reimbursement of

co-payment paid by or on behalf of the officer or firefighter for the treatment of PTSD, including counseling or therapy.

- (2) To be eligible for reimbursement of co-payment costs or coverage under this subsection, the officer or firefighter must satisfy all of the following:
- a. Agree that the employing county, municipality, or fire district is not liable under Chapter 5, Title 25, Code of Alabama 1975, to the officer or firefighter who elects to receive benefits under this act. The exemption from liability provided by this paragraph is based on the specific diagnosis for which the officer or firefighter elects to receive benefits.
- b. The officer or firefighter participated in a peer support event, where such services are reasonably available, conducted by a certified peer support member where the officer or firefighter received a debriefing, defusing, or coaching session in accordance with Section 36-21-14.
- c. The officer or firefighter received certification from a licensed clinical psychologist or board certified psychiatrist licensed to practice in this state and with experience diagnosing PTSD, utilizing an evaluation that includes symptom validity testing and other procedures to rule out the presence of malingering by using established guidelines and criteria, that the officer or firefighter has post-traumatic stress disorder and that the disorder resulted solely from his or her involvement in a specific event as defined in subdivision (a) (4) which occurred in the course of

his or her employment and not from an event or events which occurred outside the line and scope of or prior to or after his or her employment.

- d. The treating clinical psychologist or board certified psychiatrist determines that the treatment, including therapy or counseling, is medically necessary.
- (c) (1) The county, municipality, or fire district employing an officer or firefighter shall provide disability payments or coverage for those officers and firefighters who qualify for the reimbursements required in subsection (b), only if both of the following additional conditions are satisfied:
- a. The treating licensed clinical psychologist or board certified psychiatrist determines the officer or firefighter is unable to continue his or her employment and is unable to return to work as a result of his or her PTSD resulting from a specific event that is eligible under subsection (b).
- b. The officer or firefighter remains in the care of the treating licensed clinical psychologist or board certified psychiatrist for treatment and provides monthly confirmation of his or her attendance at sessions, including therapy or counseling, recommended by the treating health care professional for his or her PTSD resulting from a specific event that is eligible under subsection (b).
- (2) The disability benefits required under this subsection shall be in an amount equal to 66 2/3 percent of

the officer or firefighter's base compensation at the time of the specific event. Payments shall be made on a monthly basis provided the officer or firefighter remains eligible as required in this subsection. The term of payment shall be for a total of no more than 24 months for any incident eligible under subsection (b).

- (3) An officer or firefighter who receives benefits under this subsection may only be eligible to return to work in the same or similar role with any county, municipal, or fire district when the return is authorized, in writing, by the treating licensed clinical psychologist or board certified psychiatrist who certified eligibility as required in subsection (b). In the case the clinical licensed psychologist or board certified psychiatrist who made the original diagnosis is unavailable, an officer or firefighter may receive an authorization from another clinical licensed psychologist or board certified psychiatrist who meets the standards required in paragraph (b)(2)c.
- (4) A self-insurance group established by a county under Chapter 26 of Title 11, Code of Alabama 1975, may provide the disability payments required by this subsection for an officer or firefighter employed by a member of the self-insurance group.
- (5) Any payments received by a covered employee pursuant to this act, to any extent the amounts are included in the federal adjusted gross income of the taxpayer, shall be excluded from taxable income for state income tax purposes.

Any funds received as premiums for the coverages provided by 1 2 this act may not be subject to any premium taxes otherwise 3 required by law. Section 2. The reimbursement and benefits 4 requirements of this act shall not apply to PTSD resulting 5 from specific events occurring prior to the effective date of 6 this act. 7 Section 3. This act shall become effective January 1, 2022, following its passage and approval by the Governor, 9

or its otherwise becoming law.
