2 ENROLLED, An Act,

To provide a cost-of-living increase for state employees for the fiscal year beginning October 1, 2021.

BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

Section 1. Beginning with the first pay day on or after October 1, 2021, all state employees who are listed in the classified and unclassified service of the state as defined in Section 36-26-10, Code of Alabama 1975, and all other state employees and hourly employees of the state, and all judicial personnel, officers, and employees, and all legislative personnel, officers, and employees, whether subject to the State Merit System or not, and all employees of the county health departments who are employed subject to the State Merit System and whose compensation is paid out of a budget provided and agreed upon by the state, county, or other contributing agency under the direction of the State Board of Health shall receive a salary increase of two percent.

Section 2. (a) Any cost-of-living increase granted under this act shall in no way apply to any local supplement provided to any judges or to any other local employee whose salary is tied to that of any state employee.

(b) This act shall not apply to any Merit System employee or hourly employee whose service or rate of pay is covered by any labor agreement or contract.
