SYNOPSIS: Existing law provides for the operation of various types of foster family homes.

This bill would define additional types of foster family homes.

A BILL  
TO BE ENTITLED  
AN ACT

Related to foster homes; to amend Section 38-7-2, Code of Alabama 1975; to expand the defined types of foster family homes.

BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

Section 1. Section 38-7-2, Code of Alabama 1975, is amended to read as follows:

"§38-7-2.

"Terms used in this chapter, unless the context otherwise requires, have the meanings ascribed to them in this section. When not inconsistent with the context, words used in the present tense include the future, words in the singular

1 number include the plural number, and words in the plural  
2 number include the singular number, and the word "shall" is  
3 always mandatory and not merely directory:

4 "(1) CHILD. Any person under 19 years of age, a  
5 person under the continuing jurisdiction of the juvenile court  
6 pursuant to Section 12-15-117, or a person under 21 years of  
7 age in foster care as defined by the Department of Human  
8 Resources.

9 "(2) CHILD-CARE INSTITUTION or INSTITUTION FOR CHILD  
10 CARE. A child-care facility where more than 10 children are  
11 received and maintained for the purpose of providing them with  
12 care or training or both, or transitional living program  
13 services, but does not include:

14 "a. Any institution for child care which is under  
15 the ownership or control, or both, of the State of Alabama, or  
16 which is operated or certified or licensed by another agency  
17 or department of the State of Alabama;

18 "b. Any juvenile detention home established and  
19 operated by the State of Alabama;

20 "c. Any bona fide boarding school in which children  
21 are primarily taught branches of education corresponding to  
22 those taught in public schools, grades 1 through 12, or taught  
23 in public elementary schools, high schools, or both elementary  
24 and high schools.

25 "(3) CHILD-PLACING AGENCY. A public or private  
26 child-care facility which receives, places, or arranges for  
27 the placement of any child or children in adoptive or foster

1 family homes or other facilities for child care apart from the  
2 custody of the child's or children's parents. The term  
3 includes, but is not limited to, all agencies established and  
4 maintained by a municipality or other political subdivision of  
5 the State of Alabama to protect, guard, train, or care for  
6 children outside their own homes, but does not include any  
7 circuit court or juvenile court or any duly appointed juvenile  
8 probation officer or youth counselor of the court who receives  
9 and places children under an order of the court.

10 "(4) DAY CARE CENTER. Any child-care facility  
11 receiving more than 12 children for daytime care during all or  
12 part of a day. The term includes, but is not limited to,  
13 facilities commonly called "child-care centers," "day  
14 nurseries," "nursery schools," "pre-kindergartens,"  
15 "preschools," "kindergartens," and "play groups," with or  
16 without stated educational purposes. The term further  
17 includes, but is not limited to, pre-kindergarten, preschool,  
18 kindergarten, or nursery schools or other daytime programs  
19 operated as a part of a private school and receiving children  
20 younger than lawful school age for daytime care for more than  
21 four hours a day, with or without stated educational purposes.  
22 The term does not include any of the following:

23 "a. Kindergartens or nursery schools or other  
24 daytime programs operated by public elementary systems or  
25 secondary level school units or institutions of higher  
26 learning.

1                    "b. Kindergartens or nursery schools or other  
2 daytime programs, with or without stated educational purposes,  
3 operating no more than four hours a day and receiving children  
4 younger than lawful school age.

5                    "c. Kindergartens or nursery schools or other  
6 daytime programs operated as a part of a private school and  
7 receiving children younger than lawful school age for four  
8 hours a day or less, with or without stated educational  
9 purposes.

10                   "d. Facilities operated for more than four hours a  
11 day in connection with a shopping center or service or other  
12 similar facility, where transient children are cared for  
13 temporarily while parents or custodians of the children are  
14 occupied on the premises or are in the immediate vicinity and  
15 readily available. The facilities shall meet local and state  
16 fire and health requirements.

17                   "e. Any type of day care center that is conducted on  
18 federal government premises.

19                   "f. Special activities programs for children of  
20 lawful school age including, but not limited to, athletics,  
21 crafts instruction, and similar activities conducted on an  
22 organized and periodic basis by civic, charitable, and  
23 governmental organizations, provided local and state fire and  
24 health requirements are met.

25                   "(5) DAY CARE HOME. A child-care facility which is a  
26 family home and which receives not more than six children for  
27 care during the day.

1           "(6) DEPARTMENT. The Department of Human Resources  
2 of the State of Alabama.

3           "(7) FACILITY FOR CHILD CARE or CHILD-CARE FACILITY.  
4 A facility established by any person, group of persons,  
5 agency, association, or organization, whether established for  
6 gain or otherwise, who or which receives or arranges for care  
7 or placement of one or more children, unrelated to the  
8 operator of the facility, apart from the parents, with or  
9 without the transfer of the right of custody, in any facility  
10 as defined in this chapter, established and maintained for the  
11 care of children.

12           "(8) FOSTER FAMILY HOME. A child-care facility in a  
13 residence of a family where the family receives a child or  
14 children, ~~unrelated to that family~~ whether related or not  
15 related to the family as the term "related" is defined in this  
16 section, for the purpose of providing family care or  
17 therapeutic family care and training, or transitional living  
18 program services on a full-time basis. The types of foster  
19 family homes are defined as follows:

20           ~~"a. Boarding home. A foster family home wherein the~~  
21 ~~foster family receives a child or children and receives~~  
22 ~~payment for their care. The number of children so received~~  
23 ~~shall not exceed six, unless the children are of common~~  
24 ~~parentage.~~

25           "a. Traditional foster family home. A child care  
26 facility in a residence of a family where the family receives  
27 a child or children, not related to that family as that term

1 is defined in Section 12-15-301(13), for the purpose of  
2 providing family care and training on a full-time basis.

3 "b. Related foster family home. A foster family home  
4 wherein the family is related to the child by blood, marriage,  
5 or adoption within the fourth degree of kinship, including  
6 only a brother, sister, uncle, aunt, first cousin,  
7 grandparent, great-grandparent, great aunt, great uncle,  
8 great-great grandparent, niece, nephew, grandniece,  
9 grandnephew, or a stepparent.

10 ~~"b.~~ c. Free home. A foster family home, whether  
11 related or not related as defined in Section 12-15-301(13),  
12 which does not receive payment for the care of a child or  
13 children and which may or may not receive the child or  
14 children for the purpose of adoption.

15 "d. Therapeutic foster family home. A child care  
16 facility in a residence of a family where the family receives  
17 a child or children for the purpose of providing therapeutic  
18 family care and training on a full-time basis.

19 "(9) GROUP DAY CARE HOME. A child-care facility  
20 which is a family home and which receives at least seven but  
21 no more than 12 children for care during part of the day where  
22 there are at least two adults present and supervising the  
23 activities.

24 "(10) GROUP HOME. A child-care facility where at  
25 least seven but not more than 10 children are received and  
26 maintained for the purpose of providing them with care or  
27 training, or both, or transitional living program services.

1           "(11) MATERNITY CENTER. A facility in which any  
2 person, agency, or corporation receives or cares for one or  
3 more minor pregnant girls, except that the term does not  
4 include hospitals.

5           "(12) NIGHT CARE FACILITY. A child-care facility  
6 which is a center or a family home receiving a child or  
7 children for care during the night. The term includes the  
8 following:

9           "a. Nighttime center. A facility which is  
10 established to receive more than 12 children for nighttime  
11 care.

12           "b. Nighttime home. A family home which receives no  
13 more than six children for nighttime care.

14           "c. Group nighttime home. A child-care facility  
15 which is a family home which receives at least seven but no  
16 more than 12 children for nighttime care and where there are  
17 at least two adults present and supervising the activities.

18           "(13) RELATED. Any of the following relationships by  
19 blood, marriage, or adoption: Parent, grandparent, brother,  
20 sister, stepparent, stepbrother, stepsister, half brother,  
21 half sister, uncle or aunt, and their spouses.

22           "(14) TRANSITIONAL LIVING FACILITY. A child-care  
23 facility or program that is designed to give opportunities to  
24 practice independent living skills to eligible persons at  
25 least 16 years of age and under 21 years of age in foster care  
26 in a variety of residential settings with varying degrees of  
27 care and supervision."



1                   Section 2. This act shall become effective on the  
2 first day of the third month following its passage and  
3 approval by the Governor, or its otherwise becoming law.
