The amendment would also 19 authorize the use of video lottery terminals by the 20 21 entities currently licensed to conduct pari-mutuel 22 wagering and an additional site in Lowndes County 23 and to levy a state and local tax on revenue from 24 video lottery terminals and a state tax on video 25 lottery vendors; and authorize the Legislature to 26 pass general laws to implement the amendment.

locations and impose state and local taxes on gaming revenue from video lottery terminals; and allow the Legislature to implement the Alabama Lottery through appropriate general law."
