9	of Assisted Living Administrators is responsible
10	for the regulation and licensing of administrators
11	of assisted living facilities in the state.
12	This bill would revise the membership of the
13	board and the process for appointing members to the
14	board.

17	TO BE ENTITLED
18	AN ACT

20	Relating to the Board of Examiners of Assisted
21	Living Administrators; to amend Section 34-2A-3, Code of
22	Alabama 1975; to revise the membership and the process for
23	appointing members to the board.
24	BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:
25	Section 1. Section 34-2A-3, Code of Alabama 1975, is
26	amended to read as follows:
27	"\$34-2A-3.

"(a) There is created a Board of Examiners of 1 2 Assisted Living Administrators composed of nine members, seven six members as set out in this subsection, and two three 3 additional consumer members as set out in subsection (b). The 4 5 membership of the board shall be inclusive and reflect the racial, gender, geographic, urban/rural, and economic 6 7 diversity of the state All appointing authorities shall coordinate their appointments so that diversity of gender, 8 9 race, and geographical areas is reflective of the makeup of 10 this state. The seven original As the terms of members serving on the effective date of the act amending this subsection 11 12 expire, the members shall be composed as follows: Five Four 13 members shall be assisted living administrators duly licensed 14 and registered under this chapter; one member shall be a 15 physician licensed under the laws of the state; and one shall 16 be a licensed nursing home administrator who in the same or 17 contiguous facility manages assisted living beds. Appointments 18 Unless otherwise provided by this subsection, appointments to the board for those positions to be held by assisted living 19 20 administrators shall be made by the Governor, Lieutenant 21 Governor, and Speaker of the House of Representatives, on a rotating basis as determined by the board, from a list of 22 23 three nominees for each position to be submitted to the 24 Governor, Lieutenant Governor, and Speaker of the House of 25 Representatives, as applicable, by the Assisted Living 26 Association of Alabama, Inc board. The appointment of the 27 nursing home administrator shall be made from a list of three

nominees submitted to the Governor by the Alabama Nursing Home
Association, Inc. The appointment to the board of the member
for the position to be held by a physician shall be made from
a list of three nominees submitted to the Governor by the
Medical Association of the State of Alabama.

6 "(b) Within 30 days of March 1, 2002, the Governor 7 shall appoint two consumer members of the board. The consumer 8 members shall vote in all matters. At least one consumer 9 member shall be 65 years of age or older and no consumer 10 member, or a spouse or immediate family member of a consumer 11 member, shall be a licensee of the board or be employed in the 12 assisted living profession.

13 "(c) When the terms of all members of the board 14 expire in April 2005, the Governor shall appoint five members 15 to two-year terms and four members to three-year terms as follows: Three assisted living administrators, the licensed 16 nursing home administrator, and one consumer member shall be 17 18 appointed to two-year terms; two assisted living administrators, the licensed physician, and one consumer 19 20 member shall be appointed to three-year terms. Thereafter, all 21 members shall serve three-year terms of office.

"(d) All members of the board shall be citizens ofthe United States and shall be residents of the state.

"(e) Except as otherwise provided in this section,
each member shall serve three-year staggered terms and no
board member shall serve more than two consecutive full

three-year terms. All members shall continue to serve until
 the Governor appoints a successor.

"(f) The Governor may remove any board member for misconduct, incapacity, incompetence, or neglect of duty after the board member so charged has been served with a written statement of charges and has been given an opportunity to be heard. Absence from any three consecutive meetings of the board within a calendar year, without cause acceptable to the Governor and the board, shall be deemed cause for removal.

10 "(g) Any vacancy created by the death, resignation, 11 or removal of any board member shall be filled by the Governor 12 for the unexpired term in the same manner as required by this 13 chapter to make appointments.

"(h) Each member of the board shall receive a per 14 15 diem fee of not less than fifty dollars (\$50) nor more than one hundred dollars (\$100) to be determined by the board for 16 17 the time spent in the performance of official duties. Each member shall be reimbursed for all necessary and proper travel 18 19 and incidental expenses incurred in implementing this chapter 20 as is provided to state employees by the laws of the state and 21 regulations of the State Personnel Director. In setting the per diem fee, the board shall give due consideration to funds 22 23 which are available for that purpose.

"(i) The board shall hold four or more meetings a
year. A majority of the members of the board shall constitute
a quorum at any meeting except as provided in Section
34-2A-13. A majority vote of the members present shall be

sufficient to transact the business of the board except as provided in Section 34-2A-13. Meetings may be called by the chair or by a majority of the members of the board. Members shall be given seven days' written notice of all meetings.

5 "(j) The board shall annually elect from its members a chair and a vice-chair, at the first meeting of the board 6 7 held after October 1 of each year, and each shall serve until the first meeting held after October 1 of the following year. 8 9 In the event of the death, resignation, or removal of the 10 chair from the board, the vice-chair shall succeed as chair for the remainder of the unexpired term. In the event of the 11 death, resignation, removal, or succession to the office of 12 13 chair of a vice-chair, a successor shall be elected by the board to fill the remainder of the unexpired term as 14 vice-chair. The chair, or in the absence of the chair, the 15 vice-chair, shall preside at all meetings of the board. The 16 17 chair of the board may appoint an executive director to the 18 board, with the consent of the members of the board, who shall serve at the pleasure of the board. The board shall fix the 19 20 salary of the executive director. The executive director shall 21 be the executive officer to the board but may not be a member of the board. The executive director shall have those powers 22 23 and shall perform those duties as are prescribed by law and 24 the rules and regulations of the board. A clerk and sufficient 25 deputy clerks to adequately assist the board and executive director in the keeping of the records and in the performance 26

of their duties may be appointed by the board subject to the
 Merit System.

3 "(k) The board is subject to the Alabama Sunset Law
4 of 1981, and is classified as an enumerated agency pursuant to
5 Section 41-20-3. The board shall automatically terminate on
6 October 1, 2004, and every four years thereafter, unless a
7 bill is passed that the board be continued, modified, or
8 reestablished."

9 Section 2. This act shall become effective on the 10 first day of the third month following its passage and 11 approval by the Governor, or its otherwise becoming law.
