PROPOSED AMENDMENT

In Jefferson County, notwithstanding any other provision of law or this constitution, the county, a municipality in the county, or a local governmental entity in the county, or the agent of any of the foregoing, offering residential garbage service, shall offer residential garbage service to the tenant or tenants of residential rental property without discrimination as to the terms that the garbage service is offered to the owner of the property, and the county, a municipality in the county, or other local governmental entity in the county, or the agent of any of the foregoing, may not require garbage service offered by the county, a municipality in the county, or other local governmental entity in the county to be in the name of the owner of residential rental property. This amendment shall not be interpreted to impair the obligation of any contract entered into before the effective date of this amendment.

Section 2. An election upon the proposed amendment shall be held in accordance with Section 284.01 of the Constitution of Alabama of 1901, now appearing as Section 284.01 of the Official Recompilation of the Constitution of Alabama of 1901, as amended, and the election laws of this state.

Section 3. The appropriate election official shall 1 assign a ballot number for the proposed constitutional 2 3 amendment on the election ballot and shall set forth the following description of the substance or subject matter of 4 5 the proposed constitutional amendment: "Relating to Jefferson County, proposing an 6 7 amendment to the Constitution of Alabama of 1901, to prohibit the county, a municipality in the county, or other local 8 governmental entity in the county from discriminating in the 9 10 offering of residential garbage service to a tenant or tenants of residential rental property. 11 "Proposed by Act _____" 12 13 This description shall be followed by the following 14 language:

"Yes () No ()."
