2 ENROLLED, An Act,

To make a supplemental appropriation from the Education Trust Fund Advancement and Technology Fund to the Department of Education in the amount of \$12,014,402 for the fiscal year ending September 30, 2016; and to require the Department to establish an advisory committee to assist in the implementation of the Wi-Fi infrastructure.

9 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

10 Section 1. In addition to all other appropriations 11 heretofore or hereafter made, there is hereby appropriated 12 \$12,014,402 from the Education Trust Fund Advancement and 13 Technology Fund to the Department of Education for the fiscal 14 year ending September 30, 2016. This appropriation shall be 15 expended to: (1) provide funds to complete the goal of 16 providing wireless networks in all public schools or (2) 17 provide E-Rate matching funds to local school systems that 18 apply to the Federal Communications Commission (FCC) E-Rate 19 program for funds to accomplish the goal of providing wireless 20 networks in all public schools or (3) provide funds to 21 implement the local school system's state-approved technology 22 plan for any local school system with wireless networks in 23 place that meet required standards.

Section 2. (a) The Department of Education shall
 ensure that each local school system receive the designated
 funds under the following restrictions:

4 (1) Any system participating in this program that
5 does not have wireless networks in place that meet the
6 standards established herein, but are able to do so using
7 their allotted funds, may use these funds for this purpose.

8 (2) Any system participating in this program that 9 does not have wireless networks in place that meet the 10 standards established herein, and which is unable to meet 11 these standards using their allotted funds alone must apply 12 for E-Rate funds if such funds are available and if they meet 13 all other applicable conditions of the E-Rate program.

(3) Any system participating in this program that
has wireless networks in place that meet the standards
established herein, may use their allotted funds to implement
their local school system's state-approved technology plan.

18 (b) The Department of Education shall utilize the standards established in the Wireless Infrastructure 19 20 Renovation for Education (WIRED) Plan, developed, validated 21 and approved by the Alabama Education Technology Association 22 (AETA), for determining which systems meet the goal of 23 implementing high speed, standards-based Wireless Local Area 24 Networks (WLAN) in all schools. Such WLANs are the first 25 priority of this program. The funds provided for each system

shall be based on a distribution formula based on enrollment

Section 3. The Department of Education shall allo-

Section 4. (a) The school systems participating in this program shall pursue obtaining additional funding from the FCC E-Rate program in order to help complete these

wireless networks, wherever practicable. Therefore,

2 distribution of and use of the allocated funds will be subject 3 to the following provisions:

4 (1) For school systems that have met the standards established herein or that are in the process of installing 5 6 the equipment necessary to fully meet these standards and which have approved 2015 Category 2 E-Rate applications which 7 included in their funding request, in whole or in part, the 8 9 establishment of these wireless networking in schools. If 10 local funds were used as the match for these Category 2 E-Rate 11 applications to accomplish this goal, then the funds allotted 12 herein may be used, in whole or in part, to reimburse local 13 school systems that moved forward with local funds. Any funds 14 not applied to that purpose may be used to implement their 15 local school system state-approved technology plan.

(2) For school systems that have not met the 16 17 standards established herein and which have pending Category 2 18 E-Rate applications which will either advance or complete the wireless networks according to the standards established 19 20 herein. If systems were not able to provide the local match 21 for these E-Rate applications once approved, then the funds 22 allotted herein may be used for the local match required by 23 E-Rate to the extent that the amount of funds used for the 24 match are in proportion to the cost of the wireless equipment 25 contained in the E-Rate application. Any remaining funds may

be used as matching funds for additional E-Rate applications
 to meet the standards described in the WIRED Plan.

3 (3) For school systems that do not fully meet the 4 WIRED standards, but which are able to do so using their allotment without obtaining additional funding from the E-Rate 5 6 program. Upon approval by the Department, these systems may 7 use their allotment to complete their wireless networks 8 without applying for E-Rate funding and may use remaining 9 funds to implement their local school system state-approved 10 technology plan.

11 (4) For school systems that do not fully meet the 12 standards established herein which cannot complete the goal 13 without additional funding, and which are eligible to apply 14 for E-Rate funds to this purpose. These systems must submit an 15 E-Rate application for Category 2 funding to assist in the 16 establishment of the wireless networks and shall provide 17 evidence of this application in the form of an E-Rate Form 471 18 application certification notice from the FCC to the 19 Department of Education prior to expending funds from this 20 program. The E-Rate 471 application must include WLAN 21 equipment that meets or exceeds the standards established 22 herein and which is also covered under the E-Rate Category 2 23 program. Program funds issued under these conditions shall be 24 used for the E-Rate local match for the applicable E-Rate 25 funding cycle. Any amount of program funding that exceeds the

amount needed for the E-Rate match may be used to implement the local school system's state-approved technology plan, provided that the wireless networks established with the E-Rate funds meet the standards established herein.

5 (5) For school systems that have met the standards 6 established herein. Upon verification of submission of 7 purchase orders or any other supporting documents to the State 8 Department of Education, funds will be approved and released 9 to the school systems. These funds shall be used to implement 10 the local school system's state-approved technology plan.

(6) In all cases where program funds will be required to be used as an E-Rate local match these funds must be held available by the local school system until the E-Rate application is approved and the purchasing has begun.

15 Section 5. The State Department of Education shall 16 establish an advisory committee to assist in the 17 implementation of this act. The membership of the committee 18 shall consist of, but not be limited to, select board members 19 of the Alabama Education Technology Association (AETA) who 20 have experience and knowledge in the administration and management of school networks; additional members who have 21 22 experience in school networks and technology applications; and 23 select members of the Education Technology Department of the 24 State Department of Education. The membership of the advisory 25 committee shall be inclusive and shall reflect the racial,

1	gender, geographic, urban/rural, and economic diversity of the
2	state.
3	The Alabama Ahead Oversight Committee shall approve
4	the implementation of this act.
5	Section 6. All funds not expended in the current
6	fiscal year shall not revert but shall be carried forward for
7	the purpose appropriated.
8	Section 7. This act shall become effective
9	immediately upon its passage and approval by the Governor, or
10	upon its otherwise becoming law.
