1 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

Section 1. (a) Notwithstanding Sections 32-6-64, 32-6-67, and 32-6-68, Code of Alabama 1975, upon application to the judge of probate or license commissioner, compliance with motor vehicle registration and licensing laws, payment of regular fees required by law for license plates for private passenger or pleasure motor vehicles, and payment of an additional annual fee of fifty dollars (\$50), owners of motor vehicle who are residents of Alabama shall be issued distinctive Stop Domestic Violence license plates.

- (b) These plates shall be valid for five years.
- (c) Payment of required license fees and taxes for the years during which a new plate is not issued shall be evidenced as provided in Section 32-6-63, Code of Alabama 1975.
- (d) The Department of Revenue shall design the plates. The design shall be approved by the Legislative Oversight Committee for License Plates prior to production. Section 32-6-54, Code of Alabama 1975, shall not apply to the plates designed pursuant to this section.
- (e) The plates shall be issued, printed, and processed like other distinctive and personalized plates provided for in this chapter.
- (f) The net proceeds of the additional revenues derived from the sales of the distinctive motor vehicle license plates shall be distributed by the judge of probate or license commissioner to the office of the district attorney
